#### **INTIMATE LGBTQI+**

Was the first research project addressing **LGBTQI+** intimate citizenship in Southern Europe, funded by the EUROPEAN RESEARCH COUNCIL. It was based at CES (CENTRE FOR SOCIAL STUDIES – UNIVERSITY OF COIMBRA - PORTUGAL), between 2014 and 2019 (STARTING GRANT N. 338452).





In march 2014 a new large international research project started at CES. **INTIMATE - Citizenship, Care and Choice: The micropolitics of intimacy in Southern Europe** was a 5-year long project funded by the EUROPEAN RESEARCH COUNCIL and involved an interdisciplinary team of Italian, Spanish and Portuguese researchers coordinated by Ana Cristina Santos.

Guided by the fundamental sociological question of how change takes place and, concomitantly, how law and social policy adjust to and/or shape the practices and expectations of individuals concerning personal life, this research addressed intimacy from the perspective of those on the margins of social, legal and policy concerns in **Southern Europe (Portugal, Spain, Italy)** – lesbians, gay men, bisexuals and trans\* people.

**INTIMATE** is based on 3 strands:

- STRAND 1 THE MICROPOLITICS OF PARTNERING;**
- STRAND 2 THE MICROPOLITICS OF PARENTING;**
- STRAND 3 THE MICROPOLITICS OF FRIENDSHIP.**

This research involves conducting **6 cross-national qualitative studies** across the strands of partnering, parenting and friendship in each of the chosen countries. The topics covered are lesbian coupledom, polyamorous relationships, assisted conception and surrogacy, naming a child, transgender and care, and living with friends in adult life.

Results included a range of both international and national publications targeting academia and beyond, thematic conferences and participatory workshops, summer schools, internships, policy guidelines, media briefs and additional resources. Many of these outputs are available for consultation on the website.

### **What is intimacy?**

The notion of intimacy is used in this research project as an overarching frame encompassing personal relationships and relational well-being, including conjugalit, sexuality, parenthood, friendship and care. Therefore, partnering, parenting and friendship have been selected as analytical dimensions for the study of intimacy based on their significance in the construction of intimate biographies across a range of identities, backgrounds and geographic locations. Partnering, parenting and friendship constitute three different, although potentially interlinked, angles from which the idea of a ‘pure relationship’ (Giddens, 1992) that characterizes contemporary personal relationships can be tested.

### **What does micropolitics mean?**

The notion of micropolitics enables a double focus on everyday practices and expectations (biographic dimension) within the wider contextual framework of law and social policy (socio-legal dimension).

**INTIMATE - Cidadania, Cuidado e Escolha: A Micropolítica da Intimidade na Europa do Sul** teve início no CES em março de 2014. Trata-se do primeiro estudo aprofundado sobre cidadania íntima na Europa do Sul, financiado pelo EUROPEAN RESEARCH COUNCIL, desenvolvido durante 5 anos por uma equipa interdisciplinar composta por investigadoras e investigadores de Espanha, Itália e Portugal, sob coordenação de Ana Cristina Santos.

Instigado pela demanda sociológica central de conhecer processos de transformação e, em simultâneo, analisar o modo como o reportório legislativo se adequa às vivências e expectativas dos indivíduos na sua vida pessoal (ou se, pelo contrário, as condicionam), este projeto estudou a intimidade a partir da perspetiva de pessoas recorrentemente nas margens das prioridades políticas, jurídicas e sociais na **Europa do Sul (Espanha, Itália e Portugal)**: pessoas lésbicas, gays, bissexuais e trans\*.

**INTIMATE** assenta em 3 eixos:

- EIXO 1      A MICROPOLÍTICA DAS CONJUGALIDADES;**
- EIXO 2      A MICROPOLÍTICA DA PARENTALIDADE;**
- EIXO 3      A MICROPOLÍTICA DA AMIZADE.**

Foram realizados 6 estudos comparativos, de caráter qualitativo, em Espanha, Itália e Portugal sobre relações lésbicas, poliamor, procriação medicamente assistida e ‘barrigas de aluguer’, atribuição de nome a criança, redes de cuidado entre pessoas transgénero e coabitação entre amigos/as em idade adulta.

Os resultados do projeto foram divulgados em publicações internacionais e nacionais, de foro académico e não só, em conferências temáticas anuais e seminários participativos, em escolas de verão, estágios e outras atividades de extensão, em recomendações a decisores/as políticos/as e em relatórios para os meios de comunicação social, entre outros recursos. Muitos destes resultados estão disponíveis para consulta no website.

#### **A que nos referimos quando falamos em intimidade?**

A noção de intimidade funciona neste projeto enquanto enquadramento conceptual global, referindo-se a relações pessoais e relacionamentos de bem-estar, como por exemplo relações de conjugalidade, sexualidade, parentalidade, amizade e cuidado. Assim, para estudar a intimidade, selecionámos três dimensões analíticas – conjugalidade, parentalidade e amizade –, por se considerar serem centrais na construção de biografias íntimas para diferentes identidades, origens e contextos geográficos. A ideia de “relação pura” (Giddens, 1992) será assim testada por estas três diferentes, mas interligadas, dimensões de intimidade.

#### **A que nos referimos quando falamos em micropolítica?**

A ideia de micropolítica permite um enfoque analítico duplo, considerando vivências e expectativas quotidianas (dimensão biográfica) delimitadas por um quadro legislativo e de políticas sociais alargado (dimensão sociojurídica).

# OBJECTIVES

---

Changes in personal life in recent decades illustrate significant socio-cultural transformations. However, the focus of mainstream sociological literature has been the heterosexual, monogamous and reproductive couple, with little research exploring non-conventional intimacy in Southern Europe.

**INTIMATE**'s main aim is to contribute to legal, policy and cultural innovation through the findings of a comparative, empirically-grounded, research project designed to rethink citizenship, care and choice from the point of view of non-standard intimacies in three contrasting Southern European countries: Italy, Portugal and Spain.

This general objective is twofold:

- to offer a comparative qualitative study of the legal, political and cultural context for LGBT intimate citizenship in Italy, Portugal and Spain;
- to explore the experiences of transformations in partnering, parenting and friendship based on the narratives of lesbians, gay men, bisexual and transgendered people (LGBT).

As mudanças que em décadas recentes têm vindo a ocorrer no campo da vida pessoal ilustram transformações socioculturais significativas. No entanto, o foco da reflexão sociológica dominante tem sido o casal heterossexual, monogâmico e reprodutivo, mantendo-se escassa a investigação dedicada à intimidade não-convencional na Europa do Sul.

O objetivo principal do **INTIMATE** é contribuir para a inovação jurídica, política e cultural, através dos resultados de uma investigação empírica comparativa no âmbito de um projeto desenhado para repensar os temas da cidadania, do cuidado e da escolha, a partir de um ponto de vista de intimidades não-normativas em três países do Sul da Europa: Espanha, Itália e Portugal.

Este objetivo geral é duplo:

- Oferecer um estudo qualitativo comparativo acerca do contexto jurídico, político e cultural da cidadania íntima LGBT em Itália, Portugal e Espanha;
- Explorar as experiências de transformação de conjugalidade, parentalidade e amizade com base em narrativas biográficas de pessoas lésbicas, gays, bissexuais e transgénero (LGBT).

## THEORY & METHODOLOGY

**INTIMATE** produced queerly crafted scholarship. As such, our approach is inter and cross disciplinary from the theoretical outset and the empirical practice. Despite the strong influence of sociologically informed research, every output produced by team members engaged with literature from different fields such as Transgender Studies or Lesbian and Gay Studies.

The construction of an epistemological framework within **INTIMATE** benefited from this inter and cross disciplinary lens.

**INTIMATE** used empirically-grounded, qualitative research methods as the main mode of data collection. What is known as triangulation – combining multiple data collection methods – has facilitated access to evidence from different sources.

Throughout the 5 years of research, **INTIMATE** implemented a series of unconventional methodologies designed to foster collectively built epistemological and analytical frameworks:

## 1

### BIOGRAPHIC NARRATIVE INTERPRETIVE METHOD (BNIM)

**INTIMATE** team has benefited from an intensive 5 days training workshop on the BIOGRAPHIC - NARRATIVE INTERPRETIVE METHOD. This qualitative method enhances the researcher's ability to capture the complexities of real life experiences, as well as the discursive resources allocated to describe them, and how these shift over time, parallel to socio-political change. Training was provided in October 2014 at the CENTRE FOR SOCIAL STUDIES, our host institution, by Tom Wengraf and Prue Chamberlayne, authors of the method and experienced mentors. This both theoretical and hands-on training programme comprised the INTERVIEW METHOD and the INTERPRETATION METHOD, including sessions on comparison between and theorization from cases. A total number of 85 in-depth biographic interviews were conducted following BNIM METHOD. A total number of 12 BNIM - COLLECTIVE ANALYTICAL PANELS were carried out, with an average duration of 3 hours each.

## 2 VOICES OF EXPERTS

72 interviews were conducted with stakeholders, including health professionals, researchers, politicians/policy makers, legal experts and activist leaders with accumulated expertise on the topics under research in Portugal, Spain and Italy. By bringing together an array of experts to comment on cutting-edge topics of intimate citizenship **INTIMATE** contributed to a more informed, comprehensive yet detailed understanding of citizenship, care and choice in Southern Europe.



## 3 PARTICIPATORY WORKSHOPS

Workshops with country-based and international consultants (2015, 2016); advanced seminars with doctoral students and post-doctoral researchers at CES; workshops with stakeholders during Local Seminars in Lisbon (2016), Madrid (2015 and 2016) and Rome (2015 and 2016); workshops with secondary school students and staff.




## 4 QUEER METHODOLOGY

We placed particular emphasis on the role of non-normative practices of intimate citizens in the spheres of partnering, parenting and friendship. The focus on non-normativity and the micropolitics of intimacy is queer to the extent that it rejects taken for granted established theories or outcomes, whilst at the same time acknowledging queer as a locus for scientific knowledge production. All knowledge is situated, and our theoretical and methodological locus is queer. Furthermore, intimate draws on grounded theory and ascribes equal value to expert and non-expert accounts. This innovative methodological approach substantiated the one-day workshop **INTIMATE** organized around **QUEERING METHODOLOGIES** in January 2019.

## 5 STRATEGIC MEETINGS FEBRUARY 2015 - APRIL 2016

During Strategic Meetings, researchers had the chance to share concerns and decide on common strategies to address an array of situations during fieldwork. Issues of self-care, ethics and safety were properly addressed. During Strategic Meetings documents such as the Consent Form, the Informative Sheet and the Call for Participants were constructed collaboratively, and team members had the opportunity to engage into interview role-play to practice BNIM – BIOGRAPHIC NARRATIVE INTERPRETIVE METHOD. A reflexive account of work carried out so far was also a key aim, enabling crucial adjustments to the work ahead. Team building and peer-support were important dimensions of these encounters.


# TIMELINE

## Ana Cristina Santos

**PRINCIPAL INVESTIGATOR**

With a background in Sociology and a PhD in Gender Studies (University of Leeds, UK), Ana Cristina Santos is Principal Researcher at the Centre for Social Studies, University of Coimbra (CES-UC). At CES-UC she is Director of the PhD Programme Human Rights in Contemporary Societies and Chair of the Democracy, Justice and Human Rights Thematic Line. She published extensively and coordinated a number of research projects on LGBTQI+, gender, dissident embodiment, intimate citizenship and human rights, including a European Research Council Grant Award (2014-2019). She is currently leading two new research projects: Colourful Childhoods, funded by the European Commission (ref. n. 101049251, CERV-2021-DAPHNE), and REMEMBER, funded by FCT and focusing on experiences of LGBTQ+ older adults (ref. n. PTDC/SOC-ASO/4911/2021). After acting as Vice-chair of the European Sociological Association Sexuality RN (2012-2016), Vice-President of CES Scientific Board (2013-2016) and President of CES Ethics Committee (2017-2020), in 2021 she was elected for the Executive Committee of the European Sociological Association. Significant publications include Social Movements and Sexual Citizenship in Southern Europe (Palgrave Macmillan, 2013) and Sexualities Research: Critical Interjections, Diverse Methodologies, and Practical Applications (Routledge, 2017, with A. King and I. Crowhurst). Her most recent books are The SAGE Handbook of Global Sexualities (co-ed., 2020) and The Tenacity of the Couple Norm (co-authored, UCL, Open Access, 2020).

## Ana Lúcia Santos

**RESEARCHER**

Ana Lucia Santos holds a degree in Philosophy at the Faculty of Humanities of the University of Coimbra and an MA in Feminist Studies from the same university with a thesis on intersex. She is a junior researcher at Centre for Social Studies, University of Coimbra, since 2012, where she previously worked in research projects related to sexuality of disabled women and LGBTQ citizenship. Presently she is a Research Fellow in the research project REMEMBER - Recording Experiences of LGBTQ Elders in Post-Dictatorship Portugal (1974-2020). She is also a PhD student in Feminist Studies at the University of Coimbra, currently finishing her thesis on gender policies applied to non-normative bodies (trans and intersex) in sports. Her research interests focus on feminist studies, sexual citizenship, posthumanism, queer theory, crip theory, gender identity/expression, sexual characteristics. She is an activist in the LGBT/queer and feminist movements in Portugal.





## LGBT is no longer enough:

categories such as non-binary or pansexual have emerged from the data. 1/3 of the sample self-identified as trans or non-binary. 34 /85 participants are bisexual or pansexual.

## Political awareness:

centrality of self-determination and self-definition. Strong awareness about the fluidity of intimacy and that change is constitutive of being human.

## Intimacy beyond coupleddom and/or the biological kinship:

the daily experience of intimacy involves friends, ex-partners, partner's ex-partners, neighbours. The imaginary of the couple, the nuclear family or the biological reproduction, that has informed much of the sociocultural and policy framework, is inadequate.

## Intended parenthood:

31/85 had children. Contrary to heterosexual reproduction, LGBTQ people do not become parents by accident. Same-sex parenthood is based on informed choice, requiring preparation, negotiation and a long-term, matured plan. LGBTQ people are intentional parents or parents by choice, as opposed to accidental parents or parents by chance.

## Parenthood as a shared and collective responsibility,

involving family at large, but also friends or ex-partners.

## Partnering and parenting as triggers to come out:

having a partner is regarded as a factual element that validates one's sexual orientation (34 had their relationship legally recognised). Likewise, the existence of a pregnancy and/or a child supports the decision to come out to one's family of origin and/or to overcome previous dissent caused by homophobic reaction from family members in the past (25).

## The most significant source of distress is prejudice,

reported through bad experiences in the health sector (13) and schools (12), but also mental health issues (19) and first-hand experiences of LGBTphobic violence, including violence by family members (27/85), eviction from family home (4) and sexual abuse (10).

1/3 of discrimination is produced in the family context (30), followed by health professionals (16) and education (15). 1/3 of participants had an emotional and/or material rupture with the family of origin due to homo/transphobia (30).

## Precariousness in Southern Europe:

over 1/3 had a net monthly salary inferior to €999 even if over 2/3 had a college degree. High incidence of precarious job situations. Only 1/3 had a full time job.


## The “welfare-friendship”:

friends are the new family. Incidence of what can be described as intimate cohabitation, i.e., living with friends as a way to face precariousness and enhance mutual material and emotional support. Informal care provision (in sickness, financial crisis or childcare, for example) is mostly done by friends: 2/3 of the sample puts friends in their immediate circle of care providers (61), much more so than partners (44) or family of origin (39). Participants are highly involved in providing care for others (70), including friends (35).

## Equality and citizenship policies must protect relations based on friendship,

alongside other relational bonds such as kinship.



## SUMMARY

---



Data gathered in the context of women experiencing lesbian coupledom and partnering challenges the hypothesis of individualistic lives. Conversely, networks of friends and support hold increasing weight across a range of relational diversity.

Polyamorous intimate biographies offer new understandings of relationships and partnering. Considering it is less common to have only one (sexual) partner through-out the life course, these narratives must be taken into account by policy-makers.

**Os dados recolhidos em contexto de mulheres em relações lésbicas e relações de conjugalidade desafiam a tese da individualização. As redes de amizade e de apoio assumem particular importância num espetro de diversidade relacional.**

As biografias íntimas poliamorosas proporcionam novos entendimentos acerca da conjugalidade. Tendo em conta que é cada vez menos comum ter apenas um/a companheiro/a ao longo da vida, estas narrativas devem ser tomadas em consideração por decisores/as políticos/as.

## CONCEPTUAL INNOVATION

### **Relational citizenship**

(consensual, non-monogamous) to capture both the disjunctions and possibilities for reframing how we perceive, represent and manage our intimate lives vis-à-vis the state (law and social policy).

### **Relational performativity**

to describe the practices through which intimate relations are socially displayed; intimate relationships depend upon rehearsed scripts that guide interaction and become constitutive of the relational encounter.

### **Fluid kinship**

to signal the blurred boundaries between friends, partners, lovers, ex-lovers, family of origin and acquired or chosen families.

## WHAT THE DATA SUGGESTS

### LESBIAN COUPLEDOM

- Prejudice and discrimination outlive changes in law and social policy;
- Importance of a wide range of relationships, instead of increasing individualism and isolation;
- Sexual orientation is a dynamic category, under construction, an experience-based floating label;
- Multiple categories of personal identity and political belonging: (LGBTQ+, feminism, anti-austerity, animal rights, veganism, etc);
- Increasing diversity of relational models: couples living together; couples living together and with friends; couples living apart;
- Narratives of resilience towards violent family contexts, street harassment or daily and/or invisible homophobia;
- Discriminatory or inadequate situations in the context of medical care, often caused by health professionals' ignorance (e.g. non-heterosexual social and intimate experiences);
- Centrality of friendship networks, offering mutual care and material support in addition to or replacing families of origin, and particularly important in contexts of acute precariousness;
- Marital and/ or couple status influences the decision to come out to the family of origin (the existence of what is socially perceived as a stable, life-long, couple-based relationship seems to facilitate the decision to come out);
- Monogamy can become a choice after experiencing non-monogamous relationships, and vice versa (fluidity between relational models);
- Technology (e.g. dating apps, social networks, chats) plays an important role, especially amongst younger LGBTQ+ people and/or in contexts in which lesbian friendly places are absent.

### CONJUGALIDADE LÉSBICA

- Preconceito e discriminação sobrevivem às mudanças jurídicas e políticas sociais;
- Importância de uma variedade de relações em detrimento de um crescente individualismo e isolamento;
- A orientação sexual é uma categoria dinâmica, em construção, ancorada na experiência;
- Múltiplas categorias de identidade pessoal e pertença política: (e.g. LGBTQ, feminismo, anti-austeridade, direitos de animais, veganismo);
- Crescente diversidade de modelos relacionais: casais que moram juntos e com amigas/os, casais que não coabitam;
- Narrativas de resiliência perante contextos familiares violentos, assédio na rua ou homofobia diária;
- Discriminação ou situações inadequadas em contexto de cuidados médicos causados pelo desconhecimento dos profissionais de saúde: (experiências íntimas e sociais não-heterossexuais);
- Centralidade das redes de amizade (particularmente importante em contextos de precariedade) no apoio material e prestação de cuidados, em complemento ou substituição da família de origem;
- O estado civil interfere na tomada de decisão de “saída do armário” à família de origem; a existência do que é socialmente percebido como estável, vitalício, baseado numa relação de casal parece facilitar a decisão de “saída do armário”;
- A monogamia pode ser uma escolha depois de se experienciar a não-monogamia, e vice-versa (fluidez entre modelos relacionais);
- A tecnologia (e.g., redes sociais, apps) tem um papel importante, especialmente entre pessoas LGBTQ+ jovens e/ou em contextos nos quais espaços “friendly” para lésbicas são inexistentes.

# RESULTS

## WHAT THE DATA SUGGESTS

### POLYAMORY

- In times in which law and social policy are perceived as too rigid and adverse to change, polyamorous people tend to focus on sociocultural transformations;
- Legally-based concerns include pensions, inheritance and care related rights amongst different partners, such as work leaves and the recognition of non-monogamous forms of filiation;
- Fluid kinship, as defined by intimate research: blurred boundaries between friends, partners, lovers, ex-lovers, family (e.g. kinship may include a partner's partner);
- Centrality of care, both self-care and caring for others, particularly in a context of precarious conditions of employment, housing, health and life. Networks of care often involve current partners, ex-partners and partners of partners;
- Personal and relational well-being as a constitutive element of an ethics of care;
- Centrality of discourses around authenticity, self-development, personal growth, responsibility, consensus and reciprocity;
- Rejection of normative constraints attached to mainstream coupledom. Challenges to relational hierarchies, sexual exclusivity and dominant practices of romantic love;
- Refusal of hegemonic models of masculinity and gender-based binary models;
- Conceptual fluidity in the use and in the daily management of categories such as polyamory and (consensual) non-monogamies;
- Welcoming bisexual people, in comparison to the invisibilization of bisexuality within activism and mainstream discourse;
- Engaging exchange between academia and social movements, especially in relation to mainstream literature and cultural references (Ethical Slut; Opening Up);
- Importance of safe spaces in activism, virtual outlets and globalized academia as sources information, support and network;

### POLIAMOR

- Quando a lei e as políticas sociais são percebidas como demasiado rígidas à mudança, as pessoas poliamorosas tendem a centrar a atenção na possibilidade de transformações socioculturais;
- Preocupações de foro jurídico incluem pensões, herança e prestação de cuidados a diferentes companheiros/as, dispensas laborais e reconhecimento de filiação não monogâmicas;
- Parentesco fluído, definido como fronteiras diluídas entre pessoas amigas, companheiras, ex-companheiras, familiares (pode incluir o companheiro do meu companheiro, por exemplo);
- Centralidade de discursos sobre autenticidade, auto-desenvolvimento, crescimento pessoal, responsabilidade, consenso e reciprocidade;
- Bem-estar pessoal e relacional como elemento constitutivo de uma ética do cuidado;
- Rejeição de constrangimentos normativos associados à conjugalidade dominante. Resistências às hierarquias relacionais, exclusividade sexual e práticas de amor romântico;
- Rejeição de modelos hegemónicos de masculinidade e binarismo de género;
- Fluidez conceptual no uso de categorias como poliamor e não-monogamias (consensuais);
- Acolhimento positivo de pessoas bissexuais face à invisibilidade da bissexualidade no ativismo e no discurso dominante;
- Diálogo entre academia e movimentos sociais, especialmente em relação à literatura dominante e referências culturais (Ethical Slut; Opening Up);
- Importância de espaços seguros no ativismo, nos espaços virtuais e na academia globalizada enquanto fontes de informação, apoio e construção de redes.

**Significant developments regarding the ways in which people decide to be or remain partnered demand urgent adjustments in law and social policy in order to include same-sex and consensual non-monogamous relationships.**

## RECOMMENDATIONS

- Developing a relational-fair welfare:** decentring coupledom as the main locus for family-based law and social policy.
- Queering kinship:** political, legal and conceptual reframing of what family and kinship mean.
- Adequate training:** to prevent and fight against homophobia, transphobia and mononormativity across different sectors of society (e.g. schools, hospitals, prisons, etc.).
- Patient-centred medical care and information:** courses included in Medical Training addressing sexual orientation, gender identity and relational diversity, especially in the fields of General Practice, Gynaecology and Psychiatry.
- Promoting sexual health:** adequate information provided to patients who search for safe-sex between women or safe-sex with multiple partners.
- Strengthening the welfare state:** economic precariousness hinders the prospects of autonomous, self-determined intimate lives.
- Promoting queer public sociology and scholar-activist work.**
- Encouraging social visibility of transgender, intersex and/or older LGBTQ people** in lesbian and/or non-monogamous relationships, with a particular emphasis on media and popular culture.
- Ensuring schools are safe spaces** for sexually and gender diverse students and staff.
- Promoting pedagogical contents on family diversity** (e.g. sexuality, gender and relational diversity) in the curricula since early childhood.
- Encouraging task forces and interdisciplinary networking,** involving parliamentarians, journalists, health professionals, lawmakers, NGOs, students and researchers.
- Thinking intersectionally:** identities are not crystalized or exclusionary; they change in the life course; they overlap; multiple belongings require inclusive laws and social policy in all sectors of human experience.
- Supporting community spaces:** LGBTQ+ community spaces should be more and safer, and specific measures should be taken to promote leadership by lesbian or bisexual women and transgender or intersex people.
- Raising awareness and demanding action:** the full respect for intimate citizenship, regardless of sexual orientation or relational status, is not a bonus; it is a constitutive element of any democratic regime.
- Rethinking citizenship:** data suggest decision-makers and scholars need to change the way in which citizenship is framed and enacted by law, social policy and sociocultural outlets.

## RECOMENDAÇÕES

- Desenvolvimento de um Estado Social inclusivo face ao espetro relacional:** descentralizar o casal enquanto *locus* principal da legislação sobre família.
- Queerizar o parentesco:** reformulação política, jurídica e conceptual de família e parentesco.
- Formação adequada:** prevenir e lutar contra a homofobia, transfobia, bifobia e mononormatividade nos diferentes setores da sociedade (escolas, hospitais, prisões, etc.).
- Informação e cuidados de saúde orientados no/a paciente:** incluir formação que aborde questões sobre orientação sexual, identidade de género e diversidade relacional.
- Promoção da saúde sexual:** informação a paciente que procurem esclarecimento sobre práticas de sexo seguro entre mulheres ou múltiplas/os parceiras/os.
- Fortalecimento do Estado-providência:** a precariedade económica condiciona a possibilidade de uma vida íntima autónoma e auto-determinada.
- Promoção de uma sociologia queer pública e do trabalho académico-ativista.**
- Encorajar a visibilidade de pessoas trans, intersexo, e/ou LGBTQ mais velhas** em relações lésbicas e/ou não-monogâmicas, com particular ênfase nos media e na cultura popular.
- Garantir que as escolas são espaços seguros** para estudantes e trabalhadoras/es com identidades de género ou sexualidades diversas.

- Sensibilizar e agir:** o respeito pela cidadania íntima, independentemente da orientação sexual ou do estado relacional, não é um privilégio; é um elemento constitutivo de qualquer regime democrático.
- Repensar a cidadania:** decisores/as políticos/as e investigadoras/es devem repensar a cidadania enquanto objeto de legislação, políticas sociais.

# SUMMARY



LGBTQ+ people do not become parents by accident. Reproduction and parenting are taken seriously and require preparation, planning and negotiation. The intended nature of reproduction permeates the narratives we gathered.

Friends as well as family further contribute towards destabilizing the heterosexual/homosexual binary, challenging (hetero)normative expectations about who belongs to the most intimate space.

By providing an empirically and grounded analysis of parenting, **INTIMATE** offers invaluable insights for rethinking care practices and intimate citizenship beyond kinship in Southern Europe.

Pessoas LGBTQ+ não se tornam pais/mães por acidente. A reprodução e a parentalidade são consideradas de forma séria e exigem preparação, planeamento e negociação. A natureza intencional da reprodução permeia as narrativas recolhidas.

Amigos/as e família contribuem para desestabilizar o binário heterossexual/homossexual ao desafiarem as expectativas (hetero)normativas acerca de quem pertence ao espaço mais íntimo.

Através de uma análise da parentalidade ancorada em dados empíricos, o projecto **INTIMATE** formula propostas fundamentais para repensar as práticas de prestação de cuidados e a cidadania íntima para além das relações de parentesco na Europa do Sul.

# high

Non-heterosexual parenting entails **visibility** in every aspect of life: mothers and fathers prepare the cultural surroundings to be welcoming towards their child/ren, so they choose childcare and health professionals accordingly.

Dominant **ideologies of motherhood and other reproductive normativities** (repronormativity) are still influential in **LGBTQ+** parenting across Southern Europe.

The context of **austerity policies** is still **impacting negatively on the reproductive rights of LGBTQ+ parents** across and beyond Southern European countries, albeit some nuances and encouraging signs of change could be found.

In 2016, we witnessed the emergence of **reproductive wars in Southern Europe** that divide long-standing alliances within the feminist movements, which are now split between the segments in favour, those in favour of restrictions, and still others - against surrogacy.

# lights

Parentalidade não-heterossexual implica **visibilidade** em todos os aspetos da vida: mães e pais preparam o ambiente cultural para a criança, escolhendo, assim, profissionais de saúde e cuidados infantis de acordo com as suas necessidades.

As **ideologias dominantes de maternidade e outras normatividades reprodutivas** (repronormatividade) ainda influenciam a parentalidade **LGBTQ+** na Europa do Sul.

O contexto de **políticas de austeridade** tem um **impacto negativo sobre os direitos reprodutivos de pais e mães LGBTQ+** nos países da Europa do Sul, embora seja possível identificar sinais de mudança.

Em 2016, assistimos ao surgimento de **guerras reprodutivas na Europa do Sul** dentro dos movimentos feministas que estão agora divididos entre: posições favoráveis, posições favoráveis com restrições e outras desfavoráveis à gestação de substituição.

## WHAT THE DATA SUGGESTS

### ISSUES AROUND TIME AND AGE

- The older, the wiser: self-perception of being more prepared and better equipped for parenting after 30.
- Internalized ageism: age of the prospective parent plays a key role.
- Stages in the relationship: tendency to replicate linear times of intimacy («it was the next logical step»). The duration and/or quality of the relationship are decisive factors for partnered participants.
- When it comes to single participants, the narrative is also about choice, self-determination, and a long-lasting desire of parenting.

### MATERIAL AND EMOTIONAL COSTS OF REPRODUCTION

- Budget planning is a fundamental part of LGBTQ+ reproductive intimacy, particularly in contexts where assisted reproduction is not legally available.
- Reproductive forced displacements – when prospective parents have to travel/hire abroad to access reproduction – have an aggravated impact depending on their class status and job security, especially in the case of medical problems.

### VISIBILITY AND COMING OUT

- Parenting as a stepping stone to coming out.
- Reproductive happiness as a tool for visibility and alliance.
- Resistance to the ideology of motherhood with its rigid criteria for «good» mothering while dismissing the importance of gay fathers as parental figures.

### CHILDCARE AND EDUCATION

- Finding a supportive childcare service/school environment is a fundamental concern for parents.
- Networks of friends are fundamental in childcare practices.

### NETWORKS, NGOS AND FAMILY SUPPORT

- The existing NGO-based support is reassuring in early stages of the reproductive ladder.
- Other significant sources of support: LGBTQ+ parents association; other LGBTQ+ parents; the Internet and social media; and good practices of non-homophobic healthcare professionals.
- Even the least supportive families of origin end up welcoming the child; kinship is re-articulated through practical family support and symbolic recognition.
- Hostility of particular forms of feminist movements towards gestational surrogacy (e.g. the idea of the surrogate as an exploited woman).

### RECLAIMING PARENTHOOD AND THE RESILIENCE OF BIOLOGY

- Due to a variety of factors (e.g. religion, social constraints, internalized homophobia, lack of diverse role models in parenting, etc.), some interviewees declare their internalized assumption of not being able to become a parent.
- How «real» and socially acknowledged is each parent? Who are the closest grandparents? How do different people (neighbours, co-workers, nursery professionals, relatives, siblings, etc.) react to each parent?
- Non-heterosexual mothers become experts, and they usually provide advice to parents-to-be (including heterosexual).

### DISCLOSURE OF ORIGINS

- Children are typically aware and informed of their history of birth.
- Surrogate children sometimes get to meet the surrogates and, to a much lesser extent, gamete donors (and their families). They are also well informed about how they and babies, in general, are born.
- Many participants maintain close relationships with surrogates and consider them to be friends or sisters, like family members.

## QUESTÕES RELACIONADAS COM TEMPO E IDADE

- A idade é um posto: auto-perceção de estar melhor preparado/a e equipado/a para a parentalidade depois dos 30.
- Idadismo internalizado: a idade do/a futuro/a pai/mãe desempenha um papel importante.
- Etapas na relação: tendência para reproduzir tempos lineares de intimidade («era o próximo passo lógico»). A duração e/ou qualidade da relação são fatores decisivos para os/as participantes em parceria.
- No que concerne a participantes solteiros/as, a narrativa também se desenvolve em torno da escolha, da auto-determinação e de um duradouro desejo de ser pai/mãe.

## CUSTOS MATERIAIS E EMOCIONAIS DA REPRODUÇÃO

- Planificar um orçamento é uma parte fundamental da intimidade reprodutiva LGBTQ+, particularmente em contextos onde a reprodução assistida não está legalmente disponível.
- Deslocalização reprodutiva forçada – quando futuros/as pais/mães têm de viajar para aceder à reprodução – impacto agravado dependendo da classe e segurança no emprego, especialmente em caso de problemas de saúdes.

## VISIBILIDADE E SAÍDA DO ARMÁRIO

- Parentalidade como porta para a saída do armário.
- Bem-estar reprodutivo como ferramenta de visibilidade e aliança.
- Resistência à ideologia da maternidade e os seus critérios rígidos de «boa» mãe, ao mesmo tempo que desvaloriza a importância de pais gay como figuras parentais.

## CUIDADOS NA INFÂNCIA E EDUCAÇÃO

- Encontrar um serviço de cuidados na infância/ambiente escolar favorável é uma preocupação central para pais/mães.
- As redes de amizade são fundamentais nas práticas de cuidado na infância.

## REDES, ONGs E FAMÍLIA

- O apoio das ONGs é reconfortante nas etapas iniciais do processo reprodutivo.
- Outras fontes significativas de apoio: Associações de pais/mães LGBTQ+; outros/as pais/mães; internet e redes sociais; boas práticas de profissionais de saúde não-homofóbicos.
- Mesmo as famílias de origem menos recetivas acabam por acolher a criança; relações de parentesco são rearticuladas através do apoio da família e do reconhecimento simbólico.
- Hostilidade por parte de determinados movimentos feministas relativamente à gestação de substituição (a ideia da gestante como uma mulher explorada).

## REIVINDICAR A PARENTALIDADE E A RESILIÊNCIA DA BIOLOGIA

- Devido a uma variedade de fatores (religião, constrangimentos sociais, homofobia internalizada, falta de modelos de parentalidade diversos, etc.), algumas pessoas entrevistadas assumiram a crença internalizada de que não poderiam ser pais/mães.
- Quão «real» e socialmente reconhecido é cada pai/mãe? Quem são os avós/avôs mais próximos? Como reagem diferentes pessoas (vizinhas, colegas de trabalho, profissionais de enfermagem, parentes, irmãs/os, etc.) relativamente a cada pai/mãe?
- Mães não-heterossexuais tornam-se especialistas, e dão frequentemente conselhos a futuros pais/mães (incluindo heterossexuais).

## REVELAÇÃO DAS ORIGENS

- As crianças estão, geralmente, conscientes e informadas acerca da sua história de nascimento.
- Por vezes conhecem as suas gestantes e, esporadicamente, podem conhecer os/as dadores/as de gâmetas(e as suas famílias). Estão também informadas sobre como elas e os bebés nascem.
- Muitos/as participantes mantêm relações próximas com as gestantes e consideram-nas amigas ou irmãs, como membros de famílias.

2016 — 2017

**Significant developments regarding the ways in which people decide to be or remain partnered demand urgent adjustments in law and social policy in order to include same-sex and consensual non-monogamous relationships.**

### **MAKE THE ACCESS TO REPRODUCTION AND PARENTHOOD UNIVERSAL**

(equal treatment for parents regardless of their sexual orientation, gender identity/expression or relationship status).

- **De-biologize** the concept of parenthood and kinship.
- **Deconstruct the ideology of the biological «super-mum».**
- **Recognize** a dissident parenthood: **transparenting, multiple parents** (e.g. polyparenting), etc.
- **Eradicate administrative and institutional discrimination** against reproductively diverse families.
- **Humanize healthcare:** empathy over medicalization; easier access to translators/interpreters.
- Develop legislation protocols for gestational surrogacy in order to **protect all the parties involved** (gestational carriers, children, intended parents).
- **Empower, train, educate:** in childcare, medical training centres, childbirth and other healthcare units.
- Develop and provide **inclusive materials and practices** at childcare and schools.
- Broaden the **public debate** on surrogacy.
- Active policies **against ageism**.
- Use **inclusive language**.

### **UNIVERSALIZAR O ACESSO À REPRODUÇÃO E À PARENTALIDADE**

(tratamento igual a mães/pais independentemente da orientação sexual, expressão/identidade de género e estado relacional).

- **Des-biologizar** o conceito de parentalidade e de parentesco.
- **Desconstruir a ideologia da «super-mãe» biológica.**
- **Reconhecer parentalidades dissidentes:** transparentalidade, mães/pais múltiplas/os (poliparentalidade), etc.
- **Eliminar a discriminação administrativa e institucional** face a famílias reprodutivamente diversas.
- **Humanizar os cuidados de saúde:** mais empatia, menos medicalização; acesso facilitado a tradutores intérpretes.
- Desenvolver protocolos legislativos para a gestação de substituição de forma a **proteger todas as partes envolvidas** (gestantes, crianças, beneficiários/as).
- **Empoderar, formar, educar:** nas redes de cuidado infantil, centros de formação médica, de preparação para o parto e outras unidades de saúde.
- **Desenvolver e promover materiais e práticas inclusivas** nos cuidados infantis e em escolas.
- Promover o **debate público sobre gestação de substituição**.
- Ativar políticas **contra a discriminação com base na idade**.

# SUMMARY

---



**Friendship is a crucial component of intimacy. Networks of friends, which often include ex-partners and their current partners, play a central role in the daily management of LGBTQ+ everyday life, especially in situations of structural vulnerability and precariousness.**

Friends as well as family further contribute towards destabilizing the heterosexual/homosexual binary, challenging (hetero)normative expectations about who belongs to the most intimate space.

By providing an empirically and grounded analysis of friendship, **INTIMATE** offers invaluable insights for rethinking care practices and intimate citizenship beyond kinship in Southern Europe.

A amizade é uma componente crucial da intimidade. Redes de amigos/as, que muitas vezes incluem ex-companheiros/as e respetivos/as companheiros/as atuais, desempenham um papel central na gestão quotidiana da vida LGBTQ+, particularmente em situações de vulnerabilidade e precariedade estruturais.

Amigos/as e família contribuem para desestabilizar o binário heterossexual/homossexual ao desafiarem as expectativas (hetero)normativas acerca de quem pertence ao espaço mais íntimo.

Através de uma análise da amizade ancorada em dados empíricos, o projecto **INTIMATE** formula propostas fundamentais para repensar as práticas de prestação de cuidados e a cidadania íntima para além das relações de parentesco na Europa do Sul.

**Boundaries between love, friendship and kinship are blurred and dynamic.**

**Caring for others** takes up a substantial part in **trans biographies** and is fundamental in the lives of **LGBTQ+ people who decide to cohabit**.

As people with invaluable embodied knowledge, **trans and non-binary** people provide crucial **material, emotional, symbolic and technical support to others**. This support remains largely unacknowledged in literature on care.

**Friendship** is related to **self-care** and described as a **space of liberation** from oppressive dynamics within the family of origin and/or coupledom.

# RESULTS

## WHAT THE DATA SUGGESTS

### FRIENDSHIP

- Participants rely on friendship networks of care in everyday life.
- Friends emerged as a main source of emotional and material support, particularly for transgender and non-binary participants.
- LGBTQ+ people choose to live with friends for a great variety of reasons. These include unaffordable prices, precariousness and past experiences of transphobia and homophobia whilst house-hunting or cohabiting.
- Rent rates increase due to gentrification thus making living on one's own unaffordable. This becomes particularly serious when LGBTQ+ people are forced to share housing with people who might compromise their safety and personal well-being.
- Having pets and sharing pet care provision consolidates relational bonds between friends.
- For LGBTQ+ migrants, living with friends who have already migrated represents a way of finding emotional and practical support.
- Cohabiting with friends can become a survival tool for racialized and/or latina trans asylum seekers.

### AMIZADE

- Participantes do estudo dependem de redes de amigos/as de prestação de cuidados quotidianos.
- Amigos/as surgem como a principal fonte de apoio emocional e material, em particular para os/as participantes trans e não-binários/as.
- Pessoas LGBTQ+ optam por viver com amigos/as por uma grande variedade de razões em que se incluem preços inacessíveis, precariedade e experiências passadas de transfobia e homofobia aquando da procura de casa ou em coabitação.
- Valores das rendas aumentam devido à gentrificação, o que torna a opção de viver sozinho/a incomportável. Este problema é particularmente grave quando as pessoas LGBTQ+ são forçadas a partilhar a habitação com pessoas que podem pôr em causa a sua segurança e bem-estar.
- Ter e cuidar de animais de companhia consolida os laços relacionais entre amigos/as.
- Para migrantes LGBTQ+, viver com amigos/as que já tenham migrado constitui uma forma de encontrar apoio emocional e prático.
- Coabitar com amigos/as pode tornar-se uma ferramenta de sobrevivência para requerentes de asilo trans racializados/as e/ou latinos/as.

# recommendations

2017 — 2018

**Significant developments regarding the ways in which people decide to be or remain partnered demand urgent adjustments in law and social policy in order to include same-sex and consensual non-monogamous relationships.**

## LEGAL PROTECTION FOR LGBTQ+ PEOPLE WHO COHABIT

We recommend the extension of conjugality related rights to all forms of cohabitation, regardless of the sexual or affective bonds and number of cohabitants. The number of months required to access cohabiting status should be reduced. Taking the Portuguese law on shared economies as a starting point and pushing it further, these would **include**:

- Juridical regime of days-off, paid leaves and tax regimes equivalent to marriage and de facto unions.
- Specific protection in case of death of the tenant (e.g. transference of lease contracts, priority buying the house).
- Eligibility for fostering and adoption equivalent to marriage, de facto and/or civil union.
- Property regimes equivalent to marriage (e.g. community of property, inheritance rights).
- Right to choose cohabitants as significant others for hospital visits and next of kin.
- Protection from violence between cohabitants.
- Respect for cohabitation related bonds in terms of access to elderly care homes.
- Residency and work permits for migrant cohabitants as established for married couples.

### ADDRESSING LGBTQ+ HOUSING VULNERABILITY

LGBTQ+ people face specific difficulties in the access to housing. In order to develop effective policies regarding this issue, we strongly encourage public funded research on:

- Juridical regime of **days-off, paid leaves and tax regimes** equivalent to marriage and de facto unions.
- **LGBTQ+ homelessness.**
- Forms of **dispossession and displacement** of LGBTQ+ people resulting from gentrification.
- Forms of **intersectional discrimination** that LGBTQ+ people face.

#### WE ALSO RECOMMEND THE DEVELOPMENT OF:

- Social **housing policies** addressing LGBTQ+ housing vulnerability.
- Extending social housing policies for couples and families to **friends and/or cohabitants**.
- Housing policies for **LGBTQ+ asylum seekers** (during and after the asylum procedure).

### ADVANCING THE RIGHTS OF TRANS, INTERSEX AND NON-BINARY PEOPLE

- Social **awareness** of the **differences** between and specificities of **trans, non-binary and intersex** people.
- **Protocols** between Employment Centres and NGOs to tackle unemployment rates.
- Adequate **training** to **health professionals, teachers and childcare services** employees regarding gender diversity, with involvement of trans-identified speakers.
- **Depathologisation** of law, language and sociomedical practices.
- Creation of a state-based **National Support Centre** to provide legal, juridical, psychosocial and/or medical support.
- Revision of **textbooks** to represent household beyond the heteronormative nuclear family, acknowledge gender diversity and promote friendship as a valuable intimate relationship.
- Permanent **public funding** for cutting-edge research in **Gender Studies**.

2017 — 2018

**Transformações significativas a nível relacional requerem alterações legislativas urgentes de forma a incluir relações entre pessoas do mesmo sexo e relações não-monogâmicas consensuais.**

## PROTEÇÃO LEGAL PARA PESSOAS LGBTQ+ QUE VIVEM EM COABITAÇÃO

Recomendamos a ampliação dos direitos relacionados com a conjugalidade a todas as formas de coabitAÇÃO, independentemente dos laços sexuais ou afetivos e número de coabitantes. O número de meses necessário ao reconhecimento do estatuto de coabitante deve ser reduzido. Partindo da legislação portuguesa sobre economia comum e levando-a mais além, devem ser contemplados:

- **Regime jurídico do férias, licenças, faltas, baixas médicas e impostos** equivalente ao do casamento e das uniões de facto.
- **Proteção no caso específico de morte do/a inquilino/a** (p. ex., transferência dos contratos de arrendamento, direito de preferência na compra da casa).
- **Eligibilidade para acolhimento e adoção de menores** equivalente à do casamento e uniões de facto.
- **Regimes de propriedade** equivalentes aos do casamento (p. ex., comumhão de bens, direitos de sucessão).
- Possibilidade de escolher os/as **coabitantes** como pessoas com direito a **visitas de hospital e como parentes mais próximos**.
- **Proteção contra a violência entre coabitantes**.
- Respeito pelos laços entre coabitantes nas situações de **acesso a lares da terceira idade**.
- **Autorizações de trabalho e residência para migrantes** nos termos definidos para pessoas casadas.

## RECOMENDAÇÕES

### FAZER FACE À VULNERABILIDADE HABITACIONAL LGBTQ+

**As pessoas LGBTQ+** enfrentam especiais dificuldades no acesso à habitação. De forma a desenvolver políticas eficazes no que respeita a este tema, **incentivamos fortemente investigação publicamente financiada sobre:**

- Regime jurídico do férias, licenças, faltas, baixas médicas e impostos equivalente ao do casamento e das uniões de facto.
- Pessoas LGBTQ+ sem-abrigo.
- Formas de desapropriação e desalojamento de pessoas LGBTQ+ resultantes da gentrificação.
- Formas de discriminação interseccional enfrentadas pelas pessoas LGBTQ+.

### TAMBÉM RECOMENDAMOS O DESENVOLVIMENTO DE:

- Políticas de habitação social orientadas para a vulnerabilidade habitacional LGBTQ+.
- Extensão das políticas de habitação social para casais e famílias a amigos/as e coabitantes.
- Políticas de habitação para requerentes de asilo LGBTQ+ (durante e após o processo de atribuição do estatuto).

### PROMOÇÃO DOS DIREITOS DAS PESSOAS TRANS, INTERSEXO E NÃO-BINÁRIAS

- Sensibilização da população para as diferenças e especificidades das pessoas trans, não-binárias e intersexo.
- Protocolos entre Centros de Emprego e ONG com vista a descer a taxa de desemprego.
- Formação adequada de profissionais de saúde, professores e funcionários/as de instituições de acolhimento de crianças no que respeita à diversidade de género que incluam a participação de pessoas que se identificam como trans.
- Despatologização da lei, linguagem e práticas sociomédicas.
- Criação de um Centro Nacional de Apoio de caráter público que dê apoio legal, jurídico, psicosocial e/ou médico.
- Revisão dos manuais escolares de forma a que a sua representação do lar não se limite à família nuclear heteronormativa, reconheça a diversidade de género e promova a amizade como uma relação íntima de valor.
- Financiamento público permanente para investigação inovadora no campo dos Estudos de Género.





During the course of the project, we acknowledged the importance of further training in interdisciplinary academic environments, such as participating and organizing Summer Schools, collaborating in PhD programmes and other educational fora, providing methodological training and hosting short-term internships. Here is an overview of **INTIMATE** activities regarding Teaching and Training.

## HOSTING INTERNSHIPS AND SUPERVISING

---

In 2014 the **INTIMATE** team hosted a group of secondary school students for a one-week Internship called **INTIMATE – RESEARCHING SEXUALITY, FIGHTING AGAINST INEQUALITY**. This internship was included in the **CIÊNCIA VIVA** programme promoted by the **PORTUGUESE MINISTRY FOR SCIENCE AND TECHNOLOGY**. An important outcome of this internship was the documentary **COIMBRA IN THE CLOSET: A STUDY ON HETEROPHOBIA**, available at the **INTIMATE YOUTUBE CHANNEL**.

Between 2014 and 2019 **INTIMATE** has hosted 4 UNDERGRADUATE INTERNSHIPS and 3 RESEARCH STAYS FOR INTERNATIONAL VISITING SCHOLARS. We have also supervised:

## ORGANIZING SUMMER SCHOOLS

---

In 2018 the team organized the **INTIMATE SUMMER SCHOOL** called **THE GOOD, THE BAD AND THE MONSTER. QUEERS, CRIPS AND (OTHER) MISFITS OFF THE EDGE OF THE MAP** (14 -18 May). With invited lecturers from Portugal, Spain, Italy, Sweden and the UK – three of them **INTIMATE** Consultants –, this School aimed at advancing an interdisciplinary and intersectional approach to LGBTQ and Crip studies. To our best knowledge this was the first International Advanced Studies course on LGBTQI issues organized in Portuguese academia. It created unique opportunities for advanced training of graduate students and early-career researchers, at the same time as they enabled important feedback about the work being carried out. The **INTIMATE SUMMER SCHOOL** was crucial in the process of constructing a collectively built analytical framework which stems from multiple opportunities for cross country and cross disciplinary knowledge exchange. Given the success of this **SUMMER SCHOOL**, the **MONSTERS SUMMER SCHOOL** is being organized every two years.

**ADVANCED TRAINING FOR THE  
INTIMATE TEAM**

Advanced training was part of **INTIMATE**'s strategy to create a pool of scientific expertise in this area of studies, dedicating special attention to early career researchers. In 2015 researcher Tatiana Motterle finished her PhD in Social Sciences, and researchers Ana Lúcia Santos and Luciana Moreira started a PhD degree in Feminist Studies and in Human Rights in Contemporary Societies, respectively; in 2016, research manager Mafalda Esteves started her PhD in Psychology.



**ENHANCING THE IMMEDIATE  
RESEARCH ENVIRONMENT**


Since the starting date of **INTIMATE** the interest in LGBTQI studies in Southern Europe has been enhanced in ways which can be demonstrated from different angles. The research environment of the host institution CES increased its involvement in LGBTQI issues by hosting a greater number of PhD students developing thesis on LGBTQI topics, by organizing, coorganizing and/or hosting a greater number of LGBTQI -related events and by hosting the largest collection of books on LGBTQI+ topics, now fully accessible to students, staff and the public at the NORTH | SOUTH CES LIBRARY. A number of initiatives became more widely attended or were created in line with a consolidated interest in LGBTQI issues. This is the case with the GENDER WORKSHOP SERIES, coordinated by 2 **INTIMATE** researchers, and the SHARP TALKS, partially coordinated by former PhD students supervised by the **INTIMATE** PI.

An important highlight was the one-day QUEERING METHODOLOGIES WORKSHOP organized in 2019 with the presence of the team and international **INTIMATE** consultants and other guest speakers: Isabel Crowhurst, Zowie Davy, João Manuel de Oliveira, Susana Noronha and José Sena.





## PROJETOS CONCLUÍDOS

Desenvolvido no CES entre 2018 e 2021 e financiado pela agência europeia NORFACE, através do programa DIAL e da Fundação para a Ciência e a Tecnologia (FCT), o projeto CILIA - *Vidas LGBTQI+* centrou-se nos impactos da discriminação ao longo da vida a partir das vivências e experiências de pessoas LGBTQI+, com enfoque em três momentos-chave: o começo da vida ativa; o meio da carreira, a partir dos 40 anos; e a entrada na idade da reforma.

Entre 2019 e 2021, e com financiamento da Comissão Europeia, o projeto Dac - *Diversity and Childhood/ Diversidade e Infância* envolveu 9 países europeus e visou prevenir e combater a discriminação vivida por crianças e jovens LGBTQI+. Teve como parceiros institucionais o Ministério da Educação, a Comissão para a Cidadania e a Igualdade de Género (CIG) e a Associação REDE EX AEQUO. No âmbito deste projeto, mais de 300 pessoas beneficiaram do MOOC "*Tools to prevent and combat violence against LGBTI+ children and youth*", e um total de 115 profissionais que lidam com crianças e jovens receberam formação específica sobre o tema diversidade LGBTI+ na infância no contexto português.

## NOVOS PROJETOS

O projeto **REMEMBER – Vivências de Pessoas LGBTQ Idosas no Portugal Democrático (1974-2020)** foi avaliado por um júri internacional, tendo sido classificado em 1º lugar no painel de Sociologia no âmbito do concurso a financiamento científico atribuído pela Fundação para a Ciência e Tecnologia. Em 2022, o Conselho Europeu de Investigação (ERC) decidiu atribuir, pela segunda vez, a Ana Cristina Santos um financiamento na área LGBTQI+. O projeto tem como título **TRACE - Cidadania Queer ao Longo do Tempo: Envelhecimento, idadismo e políticas LGBTI+ na Europa**. Previsto para decorrer no CES entre 2023 e 2027, o projeto vencedor na categoria CONSOLIDATOR envolverá Portugal, Itália, Grécia, Eslovénia e Malta.

Este estudo assume particular relevo no momento de turbulência política que a Europa atravessa. Nas palavras da investigadora responsável, “Os países incluídos no projeto TRACE oferecem uma imagem abrangente dos direitos humanos LGBTI na Europa do Sul ao longo do tempo, desde Malta com um índice de reconhecimento de 94% a Itália com apenas 22%, segundo dados da ILGA Europa. Trata-se de países que passaram de regimes políticos ou socioculturais repressivos para modelos que oferecem alguma proteção jurídica, mas nos quais o aumento do populismo de extrema-direita e as campanhas anti-género e anti-LGBTI podem ser observadas em tempos recentes.”
