# Message fromthe Director

#### > 40<sup>th</sup> anniversary of CES

In 2018, CES will be celebrating its 40<sup>th</sup> anniversary. The celebrations will be taking place in different moments in the course of the year. Similarly to previous occasions, the goal is not simply to commemorate; on the contrary, the passage of the anniversary is understood as yet another opportunity to strengthen the work of the Centre and to promote reflection on paths taken under the perspective of CES' future development.

The celebrations will be crowned by the international conference "Imagining the future. Knowledges, experiences, alternatives", to be held from November 7<sup>th</sup> to November 10th at the University of Coimbra. The programme for the 7<sup>th</sup> – a call for papers has been issued and proposals are being received – is open to general participation, in particular by young researchers. The aim is to open up a broad space of debate, encompassing a wide diversity of research topics that are relevant for a reflection on the contemporary. Between the 8<sup>th</sup> and the 10<sup>th</sup>, the conference will bring together a group of high-profile international guests that have been invited to collectively approach several transversal topics of high relevance for the present and future of research in the social sciences and the humanities in a globalized world. In the spirit of the Centre's activity during the last 40 years, the congress aims at opening up a wide space for debate on some crucial topics of contemporary reflection that may help equate possible dimensions of a concretely imagined future.

The celebrations will be reflected on a permanent basis on CES' webpage and in CES' regular communication with the general public; a number of merchandise items allusive to the occasion will also be produced. Other scientific initiatives will be regularly announced. Participation in Coimbra's "Cultural Fair", with a programme intent on scientific outreach, should be particularly highlighted.

The celebrations are an important part of CES' strategy over the next five years of consolidating its role in the national and international scientific community, simultaneously helping to underscore the role of the Social Sciences and the Humanities in understanding the great societal challenges of our time. Under this light, the celebration of the 40<sup>th</sup> anniversary of the Centre will build in itself a part of the work programme and the scientific strategy of CES and represent yet another way to foster international recognition in the research areas CES has been pioneering.

The Centre for Social Studies (CES) of the University of Coimbra is a scientific institution focused on research and advanced training within the Social Sciences and the Humanities, adopting an inter and transdisciplinary approach. CES has been conducting research, since its foundation in 1978, with and for an inclusive, innovative and reflexive society by promoting creative critical approaches in the face of some of the most urging challenges of contemporary societies. Its goal is to continue engaging generations of exceptionally talented researchers and students in the field of the Social Sciences.

CES scientific strategy aims to democratize knowledge, revitalize human rights and contribute to the establishment of science as a public commodity. We pursue this mission by continuously reshaping our research fields in a response to the needs of the society. Our work covers a wide range of scientific activities and scope, at a national and international level. We particularly focus on the North-South and South-North dialogues, contributing to the development, dissemination and application of cutting-edge science, as well as to advanced research and training of excellence.

CES major strategic orientations are:

- To foster innovative and participatory epistemologies and methodologies;
- To stimulate a dialogue among knowledges, articulating scientific knowledge with knowledge produced by citizens and social movements;
- To strengthen relations with the Global South, focusing on shared knowledge, mutual recognition and intercultural understanding. Within this strategy, the Portuguese-speaking countries are key to fostering North-South and South-South dialogues;
- To contribute to a mutually enriching exchange of experiences worldwide with a clear focus on mapping and promoting new visions for Europe in a changing world;
- To promote culture, the arts and critical considerations of the past as means of advancing new ways of reflection and self-reflection on knowledge and society;
- To stimulate science in society and for society, widening citizens' engagement with scientific culture and participation in public policies.

Our mission encompasses a wide range of scientific and outreach activities that seek to contribute to the development, dissemination and application of cutting-edge science. The remapping of the epistemological foundations of our contemporary world is central for research and training of excellence. CES activities are planned and organized by its governing bodies, encompassing the main areas of action: research, publications, PhD programmes, outreach and advanced training.

CES activities are planned and implemented by its governing bodies – which are responsible for setting the centre's main guidelines concerning its research strategy and general management – and by its five Research Groups and dedicated Observatories – which plan and organize the actual activities encompassing the four main CES areas of action: research, outreach, advanced training and publications. These four areas are supported by a dedicated administrative structure.

In 2017, a new governing body was created – the Ethics Committee - and there were several changes to members sitting in the Scientific Board and in the Executive Board. Helena Machado stepped down from the Presidency of the Scientific Board, being replaced by Miguel Cardina, and in the Executive Board Gonçalo Canto Moniz and Ana Cordeiro Santos were replaced by Júlia Garraio and Licínia Simão.

2017 was also a year of change in the administrative structure: teams in the Publications and the Accounting Offices were strengthened, and the team in the Project Management Office was almost fully renewed.

At the end of 2017, CES' organisation and administration structure was as follows:

### » CES Governing Bodies

The Director, the Scientific Board and the General Assembly of Researchers are especially involved in defining the core scientific guidelines and strategies, while the Executive Board is responsible both for implementing those guidelines and for the daily and financial management under the monitoring of the Audit Committee.

The **Director**, Boaventura de Sousa Santos, is responsible for coordinating all research activities and for external representation.

The **Scientific Board** deliberates on all issues related to CES research activities, including defining the criteria and priorities for researcher hiring. The Board is currently presided over by Miguel Cardina, with Bruno Sena Martins and Paula Duarte Lopes serving as vice-presidents.

The **General Assembly of Researchers** comprises all researchers and decides upon the major guidelines for the Centre's activities, discusses and approves the annual budget, assesses the Executive Board's financial and activities reports, and decides on the admission of new members. It is presided over ex-officio by the Rector of the University of Coimbra, João Gabriel Silva, with vice-president Cláudia Pato de Carvalho and secretary Susana Costa.


The **Executive Board** is responsible for implementing the guidelines determined by the General Assembly and the Scientific Board; for coordinating and overseeing the research support's administrative and technical services (logistics, maintenance, accounting, administrative work, etcetera); and for submitting annual reports to the General Assembly. The Board includes three full members, elected by the General Assembly; in 2017 António Sousa Ribeiro (Coordinator), Licínia Simão and Júlia Garraio. João Paulo Dias is the appointed Executive Director.

The Audit Committee monitors budgetary implementation, delivers opinions on both management instruments and the annual financial report while also examining the financial statements. Three CES associates sit on this Committee: President - Catarina Frade, Member – Ana Maria Seixas, Member – Sara Araújo.

The **Ethics Committee** was created in 2017, as an independent, multidisciplinary and advisory body, aimed at promoting and ensuring ethical standards in scientific research, teaching and the outreach activities developed by CES. The current term (2017-2019) is chaired by Ana Cristina Santos (Chair) and Miguel Bandeira Jerónimo (Vice-chair). Researchers João Arriscado Nunes and José Manuel Mendes sit as members of this Committee, as well as Susana Silva, as an external member.

# » Administration


CES research support services include six administrative offices and one delegation in Lisbon. Assisting CES scientific activities and researchers, this administrative structure is overseen by the Executive Director acting under the authority of the Director, the Scientific Board and the Executive Board. In addition to these departments/offices, there are specific management assistance services for the Director and the Scientific Board.



In keeping with the trend set in previous years, CES steadily expanded its core administrative structure in 2017, now numbering 31 members of staff. The temporary staff member recruited to cover a maternity leave in the Publications Office in 2016 has now been incorporated into the administrative team. A trainee was admitted to the Events and Communication Office, working on a communication strategy that highlights the non-academic impact of CES activities.

In the Project Management Office, there was a change in the coordination – which until then was the responsibility of the Executive Director –, a former team member re-joined GAGEP, and two new team members were hired to replace two former project officers who stepped down to pursue a doctoral programme at CES.

Overall, in spite of the changes, the slight expansion in the administrative staff allowed for an improvement of the ratio between permanent researchers/staff. When considering the CES research community as a whole (junior researchers, post-doctoral researchers and PhD students), the ratio also improved slightly. However, the high performance of the research team at CES, and the need to permanently secure funding sources outside Portugal, has consistently amplified the pressure on its administrative structure over recent years.



\* Includes Post-doctoral Researchers, Junior Researchers and PhD students


#### » Research Groups

Five research groups organize and frame all CES research, outreach, training, communication, publications, and other such activities. These research groups are decentralized units working on broad research areas that gather researchers with different academic and disciplinary backgrounds but shared interests in interrelated themes.



## **»»** CCArq - Cities, Cultures, and Architecture

Coordinated by Carlos Fortuna, João Paulo Providência and Nancy Duxbury



CCArq aims to advance interdisciplinary approaches to investigating and mobilizing research on the cultural and architectural dimensions of cities. It develops research on historical and contemporary dynamics in the interrelation of cities, cultures, architecture, and place. Its approach links analysis and research mobilization to develop situated discourses on architecture, urban space, and the cultural dimensions of urban life. CCArq focuses on combining cultural mapping, visual, artistic, historical, and sociological research methodologies with community input.


CCArq brings together researchers from architecture, art, sociology, museology, urbanism, history, communication, literature, and cultural policy, among others. Topics of research interest include: small and medium-sized cities, urban change and regeneration, tourism, culture and heritage in local sustainable development, community-based museums, the influence of Portuguese heritage around the world, informal urbanism in the global South, participative housing processes, urban and architectural design methods, and the professional practices of Portuguese architects.

In 2017, CCArq organized an array of scientific and public events on topics including inclusive urban development, urban mobility, participatory strategies in museums, and cultural heritage and tourism for responsible local development. Of particular note is the international conference "Culture, Sustainability, and Place: Innovative Approaches for Tourism Development" in Ponta Delgada, "Geometrias'17: Pensar, Desenhar, Modelar" in Coimbra, and the workshop "Oficinas de Muhipiti: Planeamento estratégico, património, desenvolvimento" in Ilha de Moçambique. Building on expertise in urban regeneration, social housing and inclusive participatory processes, CCArq coordinates "URBiNAT: Urban Innovative and Inclusive Nature," a H2020-funded consortium launching in 2018. URBiNAT will regenerate social housing urban neighbourhoods in 7 European cities by designing and building "Healthy Corridors" featuring nature-based solutions to local issues through inclusive, participatory processes in Porto (PT), Nantes (FR) and Sofia (BG). These will then be replicated in Brussels (BE), Siena (IT), Høje-Taastrup (DK) and Nova Gorica (SI). The project is developed in partnership with local municipalities, enterprises and universities. URBiNAT prioritizes a participatory and transdisciplinary approach and is committed to the active involvement of communities, linking citizens' knowledges with professional practices and diverse scientific expertise in, e.g., social innovation, citizenship, inclusion, human rights, gender, sustainability, urban design, equipment design, urban environment and architecture.

CCArg also coordinates "CREATOUR: Creative Tourism Destination Development in Small Cities and Rural Areas" (2016-2019), a national research and application project supported by COMPETE2020, POR Lisboa, POR Algarve and FCT. CREATOUR is a transdisciplinary collaboration between 5 research centres and 40 pilot organizations (cultural organizations, municipalities, regional development agencies and local entrepreneurs) operating in 4 different regions. CREATOUR represents a new approach to integrating research and practice, pioneering a series of participatory research methodologies to bridge multidisciplinary academic and practice-based knowledges and build a national network to catalyse and support initiatives that link culture and tourism for locally-driven development in small cities and rural areas throughout Portugal.

#### »» DECIDe - Democracy, Citizenship and Law

DECIDe is one of the most heterogeneous and the largest research group at CES. Its heterogeneity is a strength, since the group represents a peer community of practice, connecting researchers with different academic backgrounds, such as political sociology, political science, education, law, anthropology, gender studies, theology, history and political philosophy, among others. The group combines in a harmonious way its 5 fundamental pillars: research, advanced training, publications, dissemination and outreach activities.

DECIDe has 5 main research areas:

- Social Transformation, Economic Citizenship and Democratization of Democracy;
- State, Justice Administration and Access to Law;
- (Anti-)racism, Colonialism and Postcolonialism;
- Epistemologies, Memories and Recognition;
- Gender, Sexuality and Disability.

There are currently 18 ongoing research projects, supported by national and international funding schemes. In 2017, DECIDe hosted 3 new research projects:

- Countering Islamophobia Through the Development of Best Practice in the Use of Counter-Narratives in EU Member States, funded by European Commission, Directorate-General Justice and Consumers, coordinated by Marta Araújo and Silvia Rodríguez Maeso;
- ETHOS: Towards a European THeory Of juStice and fairness, funded by European Commission, coordinated by Maria Paula Meneses;

• POLITICS: The politics of anti-racism in Europe and Latin America: knowledge production, decision-making and collective struggles, funded by European Research Council, coordinated by Silvia Rodríguez Maeso.

In 2017, DECIDe researchers have published 20 books, 49 book chapters, 12 papers in conference proceedings and 55 articles in scientific journals. The researchers have also promoted 8 special issues in scientific journals. The high number of publications bears witness to the relevance of DECIDE in the scientific debate. Articles were published in several national and international journals, including: Revista Crítica de Ciências Sociais, Antropologia Portuguesa, Isegoría, Political Science & Politics, Journal of Disability Policy Studies, Policy and Politics, Social Compass, Journal of Southern African Studies, Patterns of Prejudice, Journal of Moral Education and Critical Social Policy.

In 2017, DECIDE researchers have organized and participated in 138 scientific events, attended by 5.406 people – among these, 8 book presentations, 7 conferences, 30 advanced training courses, 36 seminars, 14 workshops, 6 international conferences. Furthermore, 5 CES summer schools were held:

- Epistemologias do Sul: lutas, saberes e ideias de futuro [Epistemologies of the South: struggles, knowledges and future Ideas] (22-30/06, Curia);
- Racism, Eurocentrism and Political Struggles (03-09/09, Coimbra);
- First European Summer School on Solidarity Economy (04-08/09, Lisbon);
- Globalização, direito e justiça criminal [Globalization, Law and Criminal Justice] (07-09/09, Coimbra);
- The Protection of Fundamental Rights in the EU and its Practices (21-23/09, Lisbon).

#### >>> NECES - Science, Economy and Society

Coordinated by Alison Neilson, Chiara Carrozza and Susana Costa



In 2017, the Research Group on Science, Economy and Society (NECES) engaged in 13 funded research projects, in addition to doctoral and post-doctoral research, and hosted 43 events.

NECES held two international colloquia, an international seminar, two training courses, and a CES Summer School. Other activities initiated by NECES included 3 exhibitions, 13 seminars, 10 workshops, 2 cycles, and 7 other activities; while members of the research group contributed to hundreds of activities hosted by others from CES.

"The Seeds of the Future" an international colloquium of the COMUNIX project which aimed to create networks of local communities in collective governance of common territories, was held in Italy, based on a partnership between NECES, DECIDe, Trespés (Galicia) and Participanza Agraria de Nonentola (Italy). The "7<sup>th</sup> International CES Seminar on the Foundations of Economics focused on the national histories of economic thought, circulation of economic ideas and globalization as part of the PhD program in Governance, Knowledge and Innovation, in partnership with DINAMIA-CET, Lisbon. The International Conference on Local Development took place in Faro in May, in partnership with NECES and the University of the Algarve.

During the year, NECES, in collaboration with POSTRADE, offered an advanced training course focused on citizenship and activism in health. The Exchange project offered a CES Summer School "Crime and Control: Criminal Investigation, Educational Centres and Prisons" with the participation of CES researchers as well as researchers and professionals from other institutions. In addition to classroom training, this Summer School featured a guided tour of a prison, the simulation of a trial and a guided tour of an exhibition. As extension activities, NECES offered a Science Living Stage focused on biodiversity issues and associative movements in health.

Eight workshops addressing topics related to ecology, biodiversity, new technologies, health and nature were offered by NECES. CES, as well as foreign researchers, attended NECES "Emergency Planning and New Technologies" workshop which was organized in partnership with the POSTRADE and the Risk Observatory and held at FEUC.

Other events promoted by NECES researchers included "Conversations" at the Science Museum of the University of Coimbra, an online transmission of the Conclusions of the Monsanto Tribunal, and the Comunix Community School for the active participation of young people in the governance of community areas, co-coordinated with DECIDe. During the course of the year, 7 national seminars were held, on various topics: clowning in academia, health research methodologies, new challenges to research methodology, DNA data sharing, the Prüm Treaty, and nanotechnology.

## » NHUMEP – Humanities, Migration and Peace Studies

Coordinated by Catarina Martins, Sílvia Roque and Teresa Cunha



The Humanities, Migration and Peace Studies Research Group (NHUMEP) integrates researchers from different areas in the Humanities and the Social Sciences. The group is characterized by intensive and productive interdisciplinary work and by an open dialogue between the humanities and the social sciences at large. The set of areas, fields and themes within NHUMEP is expressed in the common acceptance of the epistemological challenges posed by an analysis of contemporaneity which encompasses the construction of wide conceptual frameworks and a historically long-term comparative perspective.

In 2017 members of NHUMEP have been engaged in particular thematic collaborations across the group's different disciplines and lines of research, namely regarding:

1. Memory studies: are consolidating as a particularly relevant field within NHUMEP. Two members of NHUMEP were awarded a European Research Council Grant to conduct international research with an acknowledged impact in the international scientific community within this field: MEMOIRS. Children of Empires and European Postmemories, and CROME. Crossed Memories, Politics of Silence: The Colonial-Liberation Wars in Postcolonial Times. Within this field, there were several outreach activities, such as the partnerships with Cinema Festival Porto/Post/Doc (Oporto) and with the cycle Utopias, at the Maria Matos Theatre (Lisbon). Several national and international conferences, as well as publications, have strengthened the role of CES researchers' in this field. Other projects and activities in the field of History, Cultural and Peace Studies produced important outcomes such as the project Change to Remain? Welfare Colonialism in European Colonial Empires in Africa (1920-1975), funded by FCT, that produces a series of research articles for the newspaper Público. This consolidation has also promoted the integration of several junior and postdoctoral researchers in NHUMEP's projects and activities.

- 2. Migrations: several publications have been produced, namely within the scope of the project "Research on migration and the biographical approach: building a collaborative framework in the Portuguese context"; two international projects include the participation of NHUMEP's researchers: New Speakers in a Multilingual Europe, funded by COST Action IS1306; ILO-CALAPP - Incidentally Learning Other Cultures and Languages through an APP, funded by the European Commission; and several NHUMEP researchers are actively committed in creating an Inter-Thematic group on Migration where experimental interdisciplinary work has been producing innovative research proposals and practices with a particular focus on emergent issues such as refugees.
- 3. Feminist and Gender Studies: they have been critical to ensuring an intersectional analytical framework across fields and themes and involve a considerable number of NHUMEP's researchers from several disciplines. The widest reaching activity is the Gender Workshop Series, already in its 8th Annual edition, which promotes monthly workshops on transdisciplinary gender issues. Other events connecting gender and the arts have been promoted in close connection with the PhD Doctoral programme in Feminist Studies.

NHUMEP members have also been active in several international networks, such as the international training network "Around the Caspian", a Doctoral Training for Future Experts in Development and Cooperation with a Focus on the Caspian Region,"; and in organizing relevant international conferences such as the "Legacies of the Tricontinental, 1966-2016: Imperialism, Resistance, Law" (Coimbra) or the International Colloquium 100 Years that Shook the World. Emancipatory Hypothesis (Coimbra).

Also, in line with the objectives of CES, such as to boost science in society and for society, broadening citizens' and civil society engagement in scientific culture, several NHUMEP members have been awarded in recognition of their public and relevant contribution to citizenship and science (selection): a) 2014, Prize of the Portuguese Society of Authors for the best piece of erudite music for Choir and Orchestra; 2015 Medal of Honour of the Portuguese Society of Authors; b) 2017, Grand Prize for Translation of APT/SPA; c) Honourable Distinction of East Timor, awarded by the President of East Timor.

# » POSTRADE – Social Policies, Labour and Inequalities

Coordinated by Pedro Hespanha, Maria Filomena Gaspar and Fernando Fontes



POSTRADE aims primarily at promoting the development of critical reading and of new perspectives on problems that affect today's societies: welfare state sustainability, the market and the civil society roles on social protection, fragmentation of labour markets, demographic evolution, global environmental change, quality of life and equality of opportunities.

In 2017, POSTRADE maintained its research focus on four main areas deemed critical to present societies marked by uncertainty and risk: social policies for citizenship, social inequality production processes, psychosocial risks, social vulnerability and the new labour relations configurations.

In general terms, the objectives prioritized for 2017 to increase the number of applications for research projects, the number of publications in national and international peer reviewed journals and the number of dissemination activities, as well as to promote internationalization have been largely exceeded. POSTRADE achievements benefited from the dynamics established by the three open workgroups and networks (Grupo ECOSOL – Study Group on the Solidary Economy; Oficina ECOSOC – Workshop on Ecology and Society; RETS – Network on Relations Between Labour and Society) as well as from several active research projects including topics of gender, disability, mental health and labour relations. An example of one current research project deemed to be influential for setting the subject of independent living in political agenda is Decide - "Disability and selfdetermination: the challenge of independent living in Portugal"

(PTDC/IVC-SOC/6484/2014 - POCI-01-0145-FEDER-016803). In the international scenario POSTRADE, through a number of their researchers, became an active member of prestigious international research networks in social policy, such as EMES and ESPAnet.

POSTRADE outreach activities aimed to reach a wider public made up of distinct audiences – academics, professionals, policy makers and civil society in general - spanned a fairly diverse range. Some examples are:

- Organization of the "First European Summer School on Solidarity Economy: Is it possible to foster a common agenda for Solidarity Economy in Europe?" CES Lisbon
- Itinerant Cycle of Cinema "ParaDocma -To live [the city] better, it is necessary!"
- Various Places (Coimbra)
- Organization of the International conference "Media and Sexual violence: from research to communication", CES Lisbon
- Open seminars (e.g. The crisis of the Rule of Law and legal-political instability in the Latin American presidential systems) and "oficinas" (e.g. Environment in motion: ecological and alternative conflicts)
- Exhibitions (e.g. "(Other) Maps of Coimbra", with NECES)

POSTRADE commitment to working with and for society may be well illustrated by the joint participation with other CES research groups in the programme CES Vai à Escola (CES Goes to School) with thematic sessions reaching thousands of pupils in secondary schools all across the country.

#### » Observatories

Alongside the Research Groups on broad research areas, CES provides dedicated Observatories, working on subjects of particular relevance and interconnected with civil society. Their mission is to collect and produce data for public policy assessment and public dissemination. CES currently runs the following Observatories.

#### » CRISALT - Observatory on Crisis and Alternatives

Coordinator: Manuel Carvalho da Silva



In 2017, the activities of the Observatory on Crises and Alternatives were focused on one of its main research areas - the study of the dynamics of labour and employment – under the preparation of its 2017 report. Those activities included a workshop on Employment Policies (March 15) attended by a large number of civil servants from the Portuguese Agency for Employment and Training (IEFP,) a debate in the Parliament with MPs on the 'New employment' and its features (July 11), a session devoted to the public discussion of the preliminary version of the Observatory's 2017 report, and finally the publication of the report in book form (Silva, Manuel Carvalho, Hespanha, Pedro and Caldas, José Castro Caldas (Eds), Trabalho e Políticas de Emprego: um retrocesso evitável, Lisboa: Actual). This report deals with the impact of the crisis and Troika's 'adjustment' on labour and employment, the meaning of the policies implemented under the Memorandum and their consequences in terms of unemployment and precariousness. It illustrates how labour became an 'adjustment variable' under a bailout which was meant to address

a financial 'unbalance'. It argues that revaluing work in all its dimensions – pay, security, autonomy – is crucial to revert the downward cumulative causation mechanisms fuelled by Troika's 'adjustment', namely those leading to further indebtedness, emigration and inequalities. The book was presented to the public in four sessions: Lisbon (September, 21), Coimbra (October, 31), Braga (November 28) and Porto (December, 6).

Other publications of the Observatory in 2017 included: 'Caderno do Observatório', no. 10, "O labirinto das políticas de emprego", authored by Pedro Hespanha e Jorge Caleiras; Barómetro das Crises no. 16, 'Novo emprego. Que emprego?' (June) and Barómetro das Crises no. 17, 'A dupla face da recuperação: subida do emprego, estagnação da produtividade' (November).

The Observatory publications, combined with the public appearances of its researchers, had a significant impact on the media, contributing to improve the quality of the public debate on Labour and Employment policies.

#### »» OPJ - Permanent Observatory for Justice

*Coordinator: Boaventura de Sousa Santos Executive Coordinator: Conceição Gomes* 



During 2017, the OPJ concluded the following research projects:

- The study on the functioning of the Administrative and Tax Courts, funded by the Ministry of Justice. The main objectives of this project were to identify the main problems and blockages and to present reform proposals for the administrative system and taxation justice.
- The project about the Judicial Courts in East Timor: "Challenges for a judicial system under construction", in collaboration with the Commission for the Legal Reform

in East Timor, aiming to study the judicial system in East Timor in order to propose accurate recommendations to contribute to the judicial system reform and to the development of a rational and efficient justice policy.

During 2017, the OPJ launched the following research projects:

• The consultancy within "PACED - Project for the Consolidation of the Rule of Law Consolidation in PALOP and East Timor", demanded by Camões – Portuguese Institute for Cooperation and Language, aims to organise meetings to promote best practice and experiences exchange among the actors of the institutions with competencies in the areas of corruption, money laundering and organised crime fighting and prevention.

• The exploratory study concerning the judicial system and courts' functional performance in Mozambique, in collaboration with the Mozambican Association of Judges.

The following research projects were ongoing during 2017:

- The Charter of Fundamental Rights of the European Union "in action" is a project focused on a training programme financed by the Directorate-General for Justice and Consumers which integrates theoretical seminars and practical workshops (on-site training and eLearning), providing its participants (judges, public prosecutors and lawyers) with opportunities to deepen their knowledge; exchange of best practices; elaborate a best practices training manual; and develop an online information network about the Charter.
- The project «ACURIA Assessing Courts Undertaking Restructuring and Insolvency Actions: best practices, blockages and ways of improvement», financed by the Directorate-General for Justice and Consumers, aims to identify legal and procedural strategies, blockages and best practices in the field of undertakings' insolvency and

restructuring law that can be replicated or prevented in different legal and judicial systems, therefore enabling courts to provide a more accurate and fair response.

In 2017, the study on the functioning of tax and administrative justice was presented in 2 Conferences, which took place in Lisbon (May) and Oporto (November), organized by The Portuguese Ministry of Justice.

A cycle of debates took place in Dili, East-Timor, in June, concerning "The conclusions and recommendations for a reform", promoted by The Commission for the Legal Reform, to present and discuss the main conclusions and recommendations of the study about the Courts in East Timor: "Challenges for a judicial system under construction".

Within the project "The Charter of Fundamental Rights of the European Union "in action" there were 3 training actions to 25 judges, 25 prosecutors and 25 layers, as well as an ELearning training course to the same target group, aiming to develop a sustainable training program in order to improve the knowledge on the fundamental rights protection.

During 2017, the project ACURIA has focused on obtaining a comparative perspective between the four legal frameworks under analysis (Portugal, Netherlands, Italy and Poland) and has started to assess the courts' performance in enforcing business restructuring and insolvency regimes.

#### »» OSIRIS - Observatory of Risk

Coordinators: José Manuel Mendes and Alexandre Oliveira Tavares



OSIRIS aims to develop and promote a critical perspective on risk, social vulnerability and resilience, as well as concepts and instruments for risk governance. Although focused on Portuguese society, OSIRIS also promotes European and broader international networks, especially with semi-peripheral countries and those of the Southern hemisphere, in particular countries with Portuguese as their official language.

Our objectives are established in the following four domains:

1. Research: Our specific goal is to design and implement research projects studying risk as a feature of ongoing processes of socio-economic transformation and inequalities as sources of specific vulnerability to risk. We also aim to build working platforms fostering collaboration among academics and professionals from distinct disciplinary and sectorial backgrounds in order to establish shared risk framework analyses.

- 2. Public debate: Our specific goal is to consolidate OSIRIS as a forum contributing towards increasing the quality of public debate, observing and keeping track of the activities of social movements and emerging actors concerned with risk related issues; gathering data from different sources and disseminating knowledge acquired through a variety of media formats and public events; testing and implementing participatory tools for structuring debates.
- 3. *Public policies:* Our specific goal is to foster the integration of policies, public participation and accountability as the main features of processes leading to the definition of policies addressing risk issues.

4. *Training*: Our goal here involves nurturing knowledge transfers by providing young researchers with a multidisciplinary and international learning environment, providing professionals and practitioners with innovative concepts and approaches developed in risk areas which are relevant to their field of expertise, and developing extension activities in close collaboration with schools.

During 2017, for the domains under consideration, several achievements can be highlighted, namely:

Domain 1)

- Launching of a public science research project on the aftermath of the wildfires of June, in Pedrógão Grande municipality;
- ongoing) FORLAND Hydro-geomorphologic risk in Portugal: driving forces and applications for land use planning, funded by the Foundation for Science and Technology, coordinated by IGOT, University of Lisbon;
- (ongoing) Risk AquaSoil Plano Atlântico de Gestão de Riscos no Solo e na Água [Atlantic Plan for Risk Management in Soil and Water], funded by the European Regional Development Fund;
- (completed) Intermunicipal Risk Management Plan for the Intermunicipal Community of the Region of Coimbra (CIM-RC) Report. The main project objective consisted of strengthening the local institutional capacity to manage natural and technological risks;
- Journal article on a thematic number from the International Journal of Disaster Risk Science and several other articles on peer-reviewed journals authored/co-authored by OSIRIS researchers;

#### Domain 2)

• Several OSIRIS members have been actively engaged in the public debate taking place in Portugal after the extreme events of 2017. These contributions included interviews for the main television broadcasts;

 José Manuel Mendes held a collaboration as an opinion-maker in newspaper Público. The resulting articles focused mostly the topics of risk management and civil protection policies;

#### Domain 3)

- OSIRIS has been appointed as an official scientific consultant by the Associação de Vítimas dos Incêndios de Pedrógão Grande (AVIPG);
- José Manuel Mendes is a consultant for food safety at the Portuguese Food Safety and Economic Authority and the Tsunami Research, Monitoring and Early Warning Group of the Portuguese UNESCO Commission;
- Alexandre Tavares is a member of the National Platform for Catastrophe Risk Reduction;

#### Domain 4)

- Workshop on Emergency Planning and Innovative Technologies, held at the School of Economics, University of Coimbra, Portugal. This workshop included the guest speakers David Alexander and Fatemeh Farnaz;
- OSIRIS is a part of the master and doctoral risk related study programmes. The programmes are held by the University of Coimbra, in collaboration with other Portuguese institutions;
- Other relevant achievements, to be high-lighted:
- A fully revised version of the OSIRIS website has been launched during the considered period under consideration, offering a new layout and updated programming;

A FLICKR page has been created to share pictures and videos relating to extreme events in Portugal and abroad. This portfolio includes contributions from professional and amateur photographers.

#### »» CT – Trauma Centre

#### Coordinator: Luisa Sales

Trauma Centre (CT) is a unit of the University of Coimbra's Centre for Social Studies. Its priority axes of intervention are: collecting and sharing information on the subject; **carrying out research and promoting national and international networks** and cooperation protocols; promoting interdisciplinary dialogue in different areas of knowledge that interact in psychosocial responses to situations of crisis, disaster or catastrophe; and, assisting in the training of technicians and the public.

The main 2017 Trauma Centre highlights were:

- 1. Nominating the primordial focus of intervention along the year.
- 2. Promoting international participation.
- 3. Implementing different pending projects of the Trauma Centre.

Thus, under **point 1**) CT nominated **two** fundamental highlights of intervention:

- the issue of *Refugees in Europe and Psychological Trauma*.
- the issue of *Psychological Consequences of Tragic Portuguese Wildfires of 2017.*

CT will approach them through these lines of action:

• Organization of **working meetings** of reflection and discussion about those subjects, with academic associations connected with Psychotraumatology and professional groups (public or private) that work in these scopes.

As an example, CT have carried out two extended meetings on the subject "After fire: how to prevent the trauma", in July and October 2017.

 Conduction of training courses for technicians who provide help – presenting the best psychological care practices with victims of potentially traumatic situations, but also to teach prevention/protection strategies to the technicians themselves in the face of increased stress, such as burnout or vicarious trauma.

Examples of this are the 1<sup>st</sup> Psychosocial Aid Training Course for Fire Victims' Support Teams (July 2017), aimed at workers of the Social Security Institute of the wildfires region of Pedrogão Grande, and the 2<sup>nd</sup> Psychosocial Aid Training Course for Fire Victims' Support Teams (November 2017), for workers from all over the country, from the Social Security Institute.

Other examples include training sessions requested by three municipalities affected by the wildfires in October, aimed at different professional groups - health unit's professionals, elementary and secondary school teachers and municipality technicians.

- In the period immediately following the June wildfires, CT organized and provided in its' website an *informative folder* with intervention/prevention manuals of trauma, as well as other informative documents of relevance. CT have also made public a direct *e-mail for immediate response* to questions surrounding the Psychological Trauma, formulated by psychosocial intervention technicians or volunteers acting on the field.
- Finally, CT organized, autonomously and in partnership, a series of sessions focused on human trafficking: "*Mission impossible? A culturally informed approach to trauma informed care*", October 2017.

Under **point 2**) we would correspondingly highlight:

- Integration within the **ESTSS** (European Society for Traumatic Stress Studies) board of directors
- Integration within a ESTSS Taskforce regarding Refugees.
- Integration within a European network of study and research on Terrorism (*Euro*-

*pean Network for Terror* Attack Responses: preparedness and Early Interventions).

- Attendance on the **bi-annual conference of the ESTSS**, on June 2017. CT researchers presented a high number of papers and had an active participation in round tables and symposiums (Odense, Denmark).
- Integration within a European consortium that translated into several languages, subtitled and spread a formative film "*Through memories* – *the road to trauma*..." of the Elfriede Dietrich Foundation, about the therapeutic interventions in the psychological trauma.
- Organization of the *III Psychotraumatology Course*, with an ESTSS approved curricular evaluation and access to the European General Psychotraumatologist certificate.
- Welcoming of Bita Ghafoori, Long Beach Trauma Recovery Centre director and California State University Long Beach teacher, with whom the CT carried out a series of meetings and activities.

- Within the framework of **point 3**), the following achievements can be highlighted:
- Initiation of the *III Psychotraumatology Course of Trauma Centre/CES*, with monthly sessions and duration from October 2017 to October 2018.
- Integration into the Scientific Committee of the new *Resource Centre on Stress in Military Context (CRSCM)*, commissioned by the Portuguese National Ministry of Defence, welcoming the structure's clinical department project.
- Launching of the first *infoTRAUMA* number, the new CT newsletter.
- Meetings with professional associations of journalists for structuring future joint activities.
- Founding of a **Therapists Grant**, dedicated to intervention in Psychological Trauma. Creation of a **direct e-mail**, specific to issues and questions about Psychological Trauma and its consequences.



### » PEOPLES' - Observatory on Participation, Innovation and Local Government

Coordinator: Giovanni Allegretti



The Observatory aims at monitoring phenomena related to the growing role of participatory innovations in the renewal of public policies, especially at local level.

In 2017, the Observatory's work was strictly linked to the "EMPATIA" Project (funded by Horizon 2020) and the "Communix Project" (Funded by Erasmus+ programme). It therefore worked on the thematic knots of Information and Communication Technologies for Participation, and Participation in the Management of Rural Collective Lands.

During 2017, the main events of PEOPLEs' in cooperation with the two projects were:

7 Training workshops about Participation and ICTs in the 7 Regions of Portugal, organized with RAP (Network of Participatory Local Authorities) and EMPATIA (January/ July 2017).

A showcase on the "Empaville" Role-game in the "Mostra de Ciência" held at Alma Shopping, in collaboration with Biennal of Public Space of Rome (February 24-25, 2017)

The Study Tour in Portugal for 15 Local Authorities and technical staff of the Association of Municipalities and Regions of Sweden (May 3-5, 2017).

The Community School of the Comunix Project organized between Pontevedra (Galicia, Spain) and Lousã (Portugal), between August 17-31, 2017

PEOPLEs' also collaborated with "CES vai à Escola" in the diffusion of the role-game "EMPAVILLE" in different schools of Portugal (Porto, Águeda, Pereira, Caldas da Rainha), to prepare students to the National Participatory Budgeting of Schools.

PEOPLEs' Team also collaborated in organizing the Coimbra public meeting of OPP (the Nation-wide Participatory Budgeting) in the Theatre "Cerca de São Bernardo", on February 9, 2017. The event included the presence of the Secretary of State Graça Fonseca. With the students of the Doctoral course "Democracy in the XXI Century" (which usually constitute the "core" of PEOPLEs' voluntary members), 10 case-studies of participatory processes were uploaded in the portal of the project "PARTICIPEDIA" (Funded by the Canadian Institute for Science). The partnership was considered successful and resulted in new small grants for CES students being renewed for 2018 and 2019.

Outside Portugal, PEOPLEs' was invited to the International Regional Conference on Public Participation in the Budget Process, organized by the Global Initiative for Fiscal Transparency in the Slovenian Senate in Lubljana, as well as several events in Brazil, Estonia, France and Russia. It also cooperated in organizing:

the International Seminar "I semi del Futuro" (Nonantola, Italy, February 4, 2017);

the seminar "Costruendo il Diritto a Partecipare: quale ruolo per i municipi?" in the Festival of Participation of l'Aquila, Italy (July, 7-9, 2017);

two thematic sessions in the "Fair on Digital Social Innovation" in Rome (February 1-2, 2017);

A seminar on Participation applied to Civil Protection was organized in the Biennial of Democracy of Turin (April 29-31, 2017);

A seminar in the Biennial of Public Space of Rome (May 24-26, 2017).

Training seminars were also held by PEO-PLEs' members in the UPO's Masters on Human Rights and Development (Seville), and in the Masters in Communication of IULM University (Milan).

In 2017, PEOPLEs' Team (which will possibly be enriched by the PhD Students of the 2018 Edition) has also been working towards organizing modules in new projects (as URBI-NAT), and events for 2018, with four seminars on Participation to be held in the United Nations' World Urban Forum (Malaysia) and in the Africities Summit (Rabat, Morocco).

# » POLICREDOS – Observatory on Religion in Public Spaces

Coordinators: Teresa Toldy and Tiago Pires Marques



In 2017, POLICREDOS developed a number of activities that may be summarized along the following section: 1) Research; 2) Scientific meetings; 3) Publications; and 4) Outreach.

### 1) Research

POLICREDOS' team has been involved in preparing an FCT I&D project titled "TEO-MAR: On the Margins of Theology: voices for a feminist postcolonial theology". The team involved: Teresa Toldy (PI); Tiago Pires Marques (Co-PI); Maria Paula Meneses, Teresa Cunha and Alberta Giorgi. In addition, POLICREDOS hosted two research internships, that of doctoral student Ana Carine Cerva, with the project "The worship of Queen Saint Elizabeth: Reflections on Religion, Catholicism e Post-Secularization in Portugal"; and Isabel Félix's postdoctoral research in the field of religion and family policies in Brazil.

### 2) Scientific meetings

POLICREDOS organized two scientific meetings in collaboration with other research centres, namely: Third Meeting of the net "Religion in Multiple Modernities", at the University of Oporto June 5 and 6, 2017; and Colloquium "Fátima: Plural Perspectives", in collaboration with CITER. The meeting took place at CES Lisboa, on January 17, 2018.

### 3) Publications

In 2017, the team produced seven scientific publications, including one edited book, one special number in a scientific journal, three book chapters and two journal articles.

#### 4) Outreach

Outreach activities included one cycle of debates around the topic "Religion, nationalism and neo-fascisms", newspaper articles and the participation on a TV broadcast to a large audience. Specifically, two debates were organized: 1) "É preciso defender a identidade", with António Araújo and José Neves (Fundação Calouste Gulbenkian, 23/5/2017); and "O Avanço dos Conservadorismos Religiosos e a Democracia que Queremos", with Isabel Felix e Ivone Gebara (CES COIM-BRA, 10/11/2017). Our presence in the media included the presence of Teresa Toldy in the following: "A Igreja fechada no seu 'Olimpo", in: Público, 25.11.2017; "La visita del papa Francisco", in: Catalunya Cristiana, 14.05.2017; "As várias faces de Fátima", in: Jornal de Letras, 10.05.2017; and participation in the commentator's panel at SIC TV during the Pope's visit to Portugal (from May 11).

As was expected, 2017 confirmed the reversal of the downward trend in research funding, ongoing since the first financial cuts occurred in the Portuguese scientific system in 2011. The overall number of funded projects increased for the first time since 2013, reaching a total of 68 projects, comparable to the numbers in 2015. The numbers now show that CES activity, fairly steady in the beginning of the 2010's, was strongly affected during the years of the economic crisis (2013 to 2016). The negative trend in the annual number of funded projects was, however, consistently countered by a steep increase in the volume of the funding itself. This reflects the internationalization effort of the research and administrative teams and a diversification of funding sources.

A change in the number of scientific events organized at CES is also noticeable in 2017. While the overall numbers decreased, events with an international scope and activities reaching out beyond academia became more evident. This is the outcome of a more carefully planned dissemination and communication strategy, committed to developing a close dialogue between the social sciences and humanities and civil society.

As in previous years, CES endeavours to produce and disseminate knowledge in 2017 were grounded in five major streams of action: Research; Publications and Dissemination; Doctoral Programmes; Outreach and Training; the North|South Library.

The effort to enhance a greater visibility and impact of the research developed at CES was grounded in six major streams of action: Research; Publications and Dissemination; Observatories; Doctoral Programmes; Outreach and Training; and North\South Library.


# » Research

The design and implementation of research projects accounted for a substantial proportion of CES activities in 2017, as these constitute the most significant means of securing national and international funding.


### > Research Projects

In 2017, the project portfolio at CES included a total of 68 research and consultancy projects. About 26% were concluded over the course of the year while the remaining were either launched or ongoing in 2017. The downward trend, in effect since 2013, in the total number of projects managed annually by CES has been reversed, as the number of active projects rose to 68.

As in previous years, CES kept up a steady increase in the international funding secured. Half (51%) of all active projects in 2017 were either funded or co-funded by international agencies. Partly as a result, as in 2016, the projects' portfolio in 2017 represents an overall funding of over 12 million Euros. Additionally, while in 2016 this high number was sustained by a few large projects, in 2017 the weight of these projects in the overall funding is smaller. Concurrently, the percentage of projects with average budgets of below 50,000 Euros again decreased from 53% in 2016 to 45% in 2017. Taken together, both figures reveal that the average project at CES in 2017 has a robust budget, often falling within an interval of 100,000 to 200,000 Eur.








The internationalization of the CES research project portfolio and the quality of the funding demonstrates the centre's increasing competitiveness and relevance within the scope of research in the Social Sciences and Humanities at a European level. In 2017, CES was managing five ERC grants, three Individual Marie Curie Fellowships and five other projects funded by the European Commission, alongside other relevant nationally and internally funded projects.

### > Research Team

As in previous years, the team was strengthened with the admission of new researchers. In 2017, seven new researchers were admitted to the Research Groups CCArq (4), DECIDe (1) and POSTRADE (2). In spite of this, the overall number of permanent researchers has decreased from 142 in 2016 to 139 in 2017. This is due to the fact that a few researchers have suspended or terminated their collaboration with CES, in view of their intensive involvement in other activities, namely teaching and public service. The research team in 2017 also included 54 junior researchers and 73 post-doctoral researchers. The Scientific Board approved a change in the status of post-doctoral researchers, which means this category now includes researchers developing work plans over longer periods of time. This implied a reclassification of post-doctoral researchers, which explains the differences in numbers from previous reports.

Junior Researchers are mainly hired on grants attributed within the research projects funded. A large part of Post-doctoral Researchers in 2017 (77%) were funded either under Individual Grant schemes (from the FCT or other international funding agencies) or within funded research projects taking place at CES. This reflects an important change in the research dynamic at CES, but also in the national scientific system: early career researchers are increasingly qualified, most of them having a PhD degree. On the other hand, the dimension and complexity of research projects ongoing at CES require highly qualified researchers. A new legal framework in place as of 2018 is expected to further the significance of post-doctoral researchers in the next couple of years.





Around 52% of the Post-doctoral Researchers in 2017 are of international origin, most of whom come from Brazil (34%) and Italy (32%). The category of other nationalities includes people from Argentina, Armenia, Belgium, France, the U.K., Romania; Rwanda and Spain.



# » Publications and Dissemination

At CES, the strategy for the dissemination of new knowledge greatly depends on the publication of research results. A large part of all registered scientific outputs in 2017 consisted of such publications. These include both individual researcher outputs and the in-house CES journals and book collections, which have been at the core of the centre's priorities over the past few years. 2017 was thus marked by a continuous enhancement of the visibility and impact of these CES publications.

In 2017, the journal *Revista Crítica de Ciências Sociais* (RCCS) reached a new level of international recognition and credibility of its contents and editorial management process, as it began to be referenced in the Core Collection of the platform Web of Science -Clarivate Analytics, through the Emerging Sources Citation Index (ESCI). In the last five years, RCCS was included in DOAJ, SciELO's catalogue, Web of Science through the SciELO Citation Index, Scopus and ERIH Plus, among others, which strengthened the impact and reach of this journal.


With regards to *e-cadernos CES*, it has been included in 2017 in the Directory of Open Access Journals (DOAJ) and is now also referenced in the European Reference Index for the Humanities and the Social Sciences (ERIH PLUS). These first international recognitions of the quality of both its articles and editorial management practices strengthens this online journal credibility and prestige. Other applications to internationally recognized indexation databases are being studied.

Alongside these important accomplishments, the investment made in making contents available via Open Access and under Creative Commons CC BY – complying with international best practices – continues to contribute to enhancing the international profile, visibility and reach of CES publications.






As a proof, the relevance of the RCCS and *e-cadernos CES* websites increased steeply, from 286,783 single users in 2016 to 351,181 in 2017 and from 105,896 in 2016 to 165,863 in 2017, respectively. The strategy of integrating an international platform dedicated to journals in the Humanities and Social Sciences proved to be very effective: the year before being included in OpenEdition Journals platform, RCCS website had only 9,219 single users (2012) and *e-cadernos CES* website 4,774 (2013). And even the *RCCS Annual Review* - the journal discontinued in 2015 after RCCS started publishing articles in English - reached through OpenEdition Journals platform 100,669 single users in 2017.



In terms of the researchers' scientific outputs, publications have again shown to be of greater importance. Following the trend of previous years, the vast majority of the Centre's scientific outputs are rendered into articles published in scientific journals, books, and book chapters. Publishing articles in scientific journals with peer review is already clearly the leading type of publication. This is the natural reflection of the strategy of intensifying the impact and internationalization of the research produced at CES.

In general terms, English overcame Portuguese as the preferred language of publication and more than half of the researchers' scientific output is published in foreign languages, confirming the trend of recent years. The publication of articles in scientific journals during the year 2017 has contributed strongly to these results.

In the case of scientific journal published articles, we may correspondingly state that English is increasingly the preferred language of publication of the researchers, being used in more than half of the articles. Articles written in Portuguese and Spanish occupy, from a distance, the following preferences.




In 2017, CES researchers published 122 scientific articles in journals indexed and classified by the Scimago Journal & Country Rank (SJR), 74% of which were published in journals classified as Q1 (51%) and Q2 (23%), which reinforces the commitment to publication in superior quality journals.

## **Open** Access

CES continues to play an active role in the pursuit of open access policies. Its presence in the institutional repository of the University of Coimbra – Estudo Geral (http://estudogeral.sib. uc.pt), initiated in September 2016, was recently strengthened.

At the end of 2017, CES community was the University of Coimbra Research and Development Unit with the largest number of documents available in open access. Of the 3,092 documents available for consultation and downloading, 1,338 are articles that have been published in national and international scientific journals.



# » Doctoral Programmes

CES is as a partner in a wide range of thematic Doctoral Programmes, in partnership both with the Faculties of the University of Coimbra and also with other universities, and correspondingly boosting the synergies nurtured by advanced research. Students benefit from an interdisciplinary research environment of excellence, where several international projects, seminars and conferences are developed, within an intense academic framework. Every Programme includes an in-residence for the first curricular year, providing not only the structured supervision of student scientific progress through curricular research seminars, but also privileged interactions with internationally renowned guest field experts.

# FCT PhD Programmes manage a total of 42 full doctoral grants to be awarded between 2013 and 2017.

Three programmes - *Human Rights and Contemporary Societies, Post-Colonialisms* and *Global Citizenship,* and *International Politics and Conflict Resolution* – are funded by the Portuguese Foundation for Science and Technology. Altogether, these three Programmes manage a total of 57 full doctoral grants, to be awarded between 2013 and 2018 and a combined budget of almost 175,000 Euros for the 2013 – 2019 period.




### > Doctoral Students

The CES Doctoral Student community numbered 477 students in 2017, remaining largely unaltered in relation to 2016.

Also reflecting another positive trend, one of the key characteristics of the CES Doctoral programmes is the sheer diversity of student backgrounds, particularly in terms of their nationalities: 45% of the students active in 2017 were foreign nationals coming from more than 30 different countries, ranging from China to Afghanistan, Ethiopia, Japan, Turkey, Malaysia, Mexico and Ecuador.

The growing internationalization of its student corpus emerges out of the programmes' own internationalization efforts achieved by securing and maintaining relevant networking with institutions and experts across South America, Africa, Asia and Europe; by investing in hands-on research practices that encourage students to engage in intensive fieldwork and to publish; and, in some cases, by adopting English as the working language. Currently, both *Human Rights in Contemporary Societies* and *International Politics and Conflict Resolution* are entirely taught in English.






# » Outreach and Training Activities

In 2017, CES organized 380 public events, including those in association with other scientific and academic institutions or in partnership with various quadrants of civil society, held in a large variety of locations not only throughout Portugal but also in other countries.



CES organised 380 public events, some of which in association with other scientific and academic institutions or in partnership with various quadrants of the civil society.



Participation in these scientific events was high throughout 2017, reaching almost 15,700 people. This was due not only to the CES vai à escola [CES Goes to School] programme but also to the ability to maintain a steady flow of participation in the events organised.


Conferences played an important role in the institution's activity, with a total of 42 such events taking place in 2017 (whether in colloquium, seminar, symposium or meeting formats), 23 of which international. They enabled the gathering of 2,144 participants from various nationalities and research areas.



A total of 37 advanced training courses were organized over this year and coaching more than a thousand students. CES remains deeply committed to promoting scientific culture in society by expanding and diversifying its offer of outreach activities. Thus, over 3,041 of the total number of 15,674 CES scientific event participants were registered under CES Vai à Escola [CES Goes to School] initiatives. These represent a corollary of the outreach activities, in conjunction with the Ciência Viva Summer Internships that welcomed 13 students to CES and provided them with the chance to experience a week as social and humanities scientists, integrated into ongoing research projects.

The participation in these scientific events continued to be high during 2017, reaching more than 15,500 people.

### > CES Goes to School - CVE


CES vai à escola (CES Goes to School) constitutes one of the Centre for Social Studies (CES) strategies for the dissemination of scientific culture, thus striving to foster contacts between its researchers and the wider community. To this extent, CES invites schools to participate in the "CES Goes to School" project. The initiative has been developing since January 2014 in partnership with 'Ciência Viva' (Living Science), correspondingly validating the importance of the work undertaken by "CES Goes to School".

This activity programme, which takes place between November and June of each school year, is dedicated to pupils of various levels of education (2nd and 3rd cycles of basic and secondary education). As such, it aims to contribute to the dissemination of knowl-




# > UNIFOJ – Legal and Judicial Training Unit

As far as advanced training is concerned, the activity of the Legal and Judicial Training Unit (Unidade de Formação Jurídica e Judiciária - UNIFOJ), created in 2012, was also noteworthy in 2017. Beyond its advanced training program Justice XXI, coordinated by the Permanent Observatory of Justice (OPJ) in partnership with the Association of Portuguese Judges and the Union of Public Prosecutors, UNIFOJ has developed several other training courses on different areas of law and justice and, in close articulation with the School of Economics of the University of Coimbra, has brought up the Specialization Course on Judicial Organization and Management. In 2014 an e-learning platform (e-UNI-FOJ) was inaugurated, particularly targeting audiences in Portuguese speaking countries, members of CPLP - Comunidade dos Países de Língua Portuguesa. During 2017, UNI-FOJ organised 31 classroom or e-learning advanced training courses, reaching more than 870 trainees in 9 different countries. Most of the training activities were organized in cooperation with other professional, private or public entities, judicial and non-judicial, aiming to involve legal and judicial professionals, practitioners and other interested audiences, like an e-learning cycle about corruption and financial and economic criminality.

### > CES Summer Schools

In 2017 CES ran seven Summer Schools attended by 227 trainees. 

# » North/South Library (BN/S)

In 2017, we continued to offer Information Literacy Advanced Training Workshops in Portuguese, English and Spanish. Determined to promote the independent research process through Bibliographic Instruction, Database Researching and Platforms of Scientific Journals Evaluation Workshops open to all CES PhD Students and Researchers, as well as to the University of Coimbra community at large, we offered **8 group sessions to 90 participants**, supplementing other initiatives of library instruction: **24 researchers participated in individual bibliographic training sessions**.

Since 2016, BNS has maintained a partnership with the **Publish do not perish: survive** *the stampede* project (http://www.ces.uc.pt/ survive\_stampede) therefore, we continued to be responsible for the co-coordination of the project and the advanced training workshops on Catalogues and database research; Citation norms and styles, and bibliography organization; Zotero & Mendeley bibliographic managers; Academic journals relevance and impact to support student scientific development. Concerning its overall activities, the library registered an increase in all its relevant indicators: attracting 326 users: 245 international users (i.e. from other institutions) and 81 CES users, both categories with representation from diverse countries. The team answered 1887 reference requests in person, by email and by phone and offered distance support to users and other libraries, by providing Interlibrary Loan service and digitized documents; its collection grew up to a total of 25232 volumes, corresponding to the addition of 935 new volumes (487 gifts and 448 purchased). The Circulation was of 7911 loans which amount to a 6.9 % growth in activity (10495 items: were lent 7911 and 2507 returned). A total of 77 book holds were placed and 440 periodicals we accessed. The CD 25 of April collection had a circulation of **159 items**. The collection development implied the searching and purchase of 448 items and a total of 935 items were catalogued, indexed and classified. The e-cadernos, CE Scontexto, Oficinas do CES and RCCS articles were also catalogued, indexed and classified (analytical entries) including the text hyperlinks so that users may have home access to digital contents.

# » AGORA – Alternative Grassroots Organizations as a Response to Austerity: perspectives from Southern Europe

Principal Investigator: Michela Giovannini

#### **Funding: Marie Curie Individual Fellow**

AGORA is an Individual Research Fellowship funded by the European Commission investigating how Social and Solidarity Economy (SSE) is politically framed, by investigating the linkages between social movements and SSE in Spain and Portugal. The specific objectives of the project are to empirically and theoretically assess under which conditions social movements are conducive to the emergence SSE organizations, and to determine the extent to which social movements shape and influence the economic, social, and especially the political dimension of SSE.

Starting from a social movement perspective, AGORA adopts an interdisciplinary approach by finding synergies between social movement scholarship, economic anthropology, organization studies and SSE scholarship (which is per se interdisciplinary), with the aim of integrating different approaches proposed by these disciplines.

In Southern Europe, the global financial cri-

to defend public welfare provision, with anti-austerity movements characterized by a call for social justice framed in solidarity and inclusion, against the perception of a reduced capacity by the state of addressing citizens' needs. This low level of trust in institutional politics has triggered the creation of alternative spaces of deliberative and participatory democracy, directed at experimenting with different political expressions.

Against this background, a crucial question is whether and how this claim for different forms of democracy has been translated by social movements into the development of grassroots organizational forms that bring increased democracy also into the economic sphere. In order to address this still under investigated question, AGORA is focusing on those grassroots economic activities that originate from the civil society and that are characterized by the prevalence of social objectives over profit maximization.



# **»»** CuCa\_RE: Cure and Care\_the rehabilitation



"CuCa\_RE: Cure and Care\_the rehabilitation" is a research project that studies healthcare buildings built in Portugal during the 20<sup>th</sup> century and their role in the public health policies during that time. It also reflects on future challenges that medical and technological developments are bringing to society as well as the urgent need to promote a sustainable built environment, namely through re-thinking obsolete medical facilities.

The study of conservation and rehabilitation of medical modernist heritage buildings implies thinking about their future re-use and considering the role of health care buildings in a not-so-far-off future. In addition, the research project questions new global perspectives concerning curing and caring in the 21<sup>st</sup> century. This implies an approach to sustainability beyond their material limits, and therefore projecting them forward in terms of cultural concepts, feelings of belonging and identity values.

CES researchers have a strong affiliation with these topics, having researched and published on the 19<sup>th</sup> century hospital, the Hansen Disease Hospital Rovisco Pais, the Sanatoria at Caramulo, the work of Bissaya Barreto and medical facilities in the welfare state, and thermal spas. In this project, CES researchers will select the case studies, direct a design workshop, support the international seminar and conference, and edit a book concerning "best practices" on rehabilitation and re-use of health care buildings. Besides ethnographic and historical methods, the research is based on a new qualitative research method (research through design) that will be piloted in this project.

The research project is led by Ana Tostões at Instituto Superior Técnico and it involves the Centre for Social Studies at UC and the Faculty of Humanities at UL. It is also supported by the Portuguese Central Administration of the Health System (ACSS), Docomomo International and the Calouste Gulbenkian Foundation, among others.



# » Ecocritical Approaches to Writings on the Amazon

Principal Investigator: Patrícia Vieira

#### Funding: Portuguese Foundation for Science and Technology

From the arrival of the first Europeans to the Amazon river basin in the sixteenth century to our days, the rainforest has been hailed as a symbol of wilderness, due to its size, inaccessibility and diverse flora and fauna. "Ecocritical Approaches to Writings on the Amazon" undertakes a critical examination of texts depicting nature in this area. Amazonian writings mirror evolving approaches to the environment, moving from an early theological framework that divides landscapes into those similar to a green hell and those resembling an earthly paradise, through the scientific and developmental rhetoric of the nineteenth and early twentieth centuries, to later protectionist and conservationist discourses. My goal is both to trace our changing approaches to the Amazon and to consider how these shed lights on current ecological problems.

The first section of the project analyses the accounts of travels in the area by early Spanish and Portuguese explorers and missionaries, such as Gaspar de Carvajal, Cristóbal de Acuña or João Daniel. I subsequently turn to portrayals of the region by North European naturalists like Alfred Russel Wallace, Henry Walter Bates and Louis Agassiz, who emphasized the scientific significance of local fauna and flora. In the third part of the study, analysing texts by Alberto Rangel, Ferreira de Castro, José Eustasio Rivera and Rómulo Gallegos, I focus on the so-called jungle novel, which flourished during the first half of the twentieth century and contrasted the perceived unruliness of the Amazonian environment with developmental discourses. I then examine portrayals of the territory from the mid-twentieth century onwards by authors like Astrid Cabral, Márcio Souza and Juan Galeano, who were heavily influenced by environmentalist thought. The final section of the project discusses what texts on the Amazon reveal about the Western attitude towards the environment from early Modernity to our days.



# » ETHOS – Towards a European THeory Of juStice and fairness

Principal Investigator at CES: Maria Paula Meneses

### Funding: European Commission – Horizon 2020

ETHOS is a project funded by the European Commission and coordinated at CES by Maria Paula Meneses (coordinated by Utrecht University). ETHOS stands for Towards a European THeory Of juStice and fairness. At its core is the impact of the ongoing financial, economic and social crises in Europe, intensifying the rise of inequalities to the fore. Whilst increases in inequalities vary amongst European states, and have evolved at different speeds at different times, it is clear that inequalities have been on the rise generally over the last decades, both in Europe and globally.

ETHOS seeks to provide building blocks for the development of the empirically informed European theory of justice by a) refining and deepening the knowledge on the European foundations of justice – both historically based and contemporary envisaged; b) enhancing the awareness of the mechanism that hinders the realisation of the justice ideals that live in contemporary Europe; c) advancing the understanding of the process of justice boundaries (fault lines) drawing and re-drawing; and d) providing guidance to politicians, policy makers, advocacies and other stakeholders on how to design and implement policies to avoid inequalities and prevent injustice. In ETHOS approach, justice is not merely an abstracted moral ideal of universal reach that is worth striving for. It is predominantly a continuously re-enacted and re-constructed, "lived" experience, embedded in firm legal, political, moral, social, economic and cultural institutions that are geared towards giving members of society what is their due.

In ETHOS project, justice will be studied in its interdependence between the ideal and the real, the normative and the practical, the formal and the informal – all set in the highly complex institutions of modern European societies. To enhance the formulation of an empirically based theory of justice, ETHOS is exploring the normative underpinnings of justice and its practical realisation in four heuristically defined domains of justice (social justice, economic justice, political justice, and civil and symbolic justice), as revealed in: a) philosophical and political tradition, b) legal framework, c) daily, bureaucratic practice, d) current public debates, and e) the accounts of the vulnerable populations in six European countries: the Netherlands, UK, Hungary, Austria, Portugal and Turkey.



# » GLOCADEMICS - 'Glocal Languages' and 'Intercultural Responsibility' in a postcolonial global academic world: Power relations between languages/cultures within and between research groups

Principal Investigator: Manuela Guilherme

### Funding: Marie Curie Individual Fellow

The GLOCADEMICS project - 'Glocal Languages' and 'Intercultural Responsibility' in a postcolonial global academic world: Power relations between languages/cultures within and between research groups" was awarded a Marie Sklodowska-Curie Outgoing Fellowship (2014-2017). Research was carried out on the representation, positioning and workings of European 'glocal' languages (English, Portuguese and Spanish) and of Indigenous languages, as well as the promotion of 'intercultural responsibility', both in language teaching and in research activities. The former included the analysis of undergraduate courses curriculum development and the teachers' conceptual frameworks about languages and cultures. However, the main focus of this project was the study of a sample of research teams, both in the Social Sciences and in the Life Sciences. All in all, the two-year study was carried out in 4 public universities in Brazil. During the first year, data were collected from language teachers (27 altogether) about their priorities in curriculum management. During the second year, data were collected through 'research on research', with 5 research groups, in 3 public universities, through individual meetings, document reading (reports, papers and



related documents on each research topic) and final focus-group interviews. Interview guides, specifically prepared for each group, dealt with the role of the languages used, conceptual negotiation, intercultural epistemological exchange and the need for suitable development programmes on the above for young researchers. During the final year back at the Centro de Estudos Sociais, the results of this two-phase empirical study in Brazil were analysed, reports and publications were submitted and a final symposium was organised. This project argued that universities should also focus on research micro-contexts, at the grassroots level, while implementing institutional agreements for the purpose of internationalisation and globalisation.



# » Countering Islamophobia through the Development of Best Practice in the use of Counter-Narratives in EU Member States

Principal Investigators at CES: Marta Araújo, Silvia Rodríguez Maeso

### Funding: European Commission – Directorate General of Justice

CIK is a two-year project funded by the European Commission - Directorate of Justice, that brings together experts from across Europe. At CES, it is coordinated by Marta Araújo and Silvia Rodríguez Maeso. The project will critically review dominant anti-Muslim narratives, and also compare the use and efficacy of prevailing counter-narratives to Islamophobia in eight European Union member states (France, Germany, Belgium, the Czech Republic, Hungary, Portugal, Greece and the UK). Findings based on normative patterns of Islamophobia and effective counter-narratives in each case will inform the production of a transferable 'Counter-Islamophobia Kit', which aims to detail best-practice in countering anti-Muslim hate across the continent. The key messages contained within the CIK will be aimed at policy makers, professionals and practitioners from across the EU.

The CIK project addresses the need for a deeper understanding and awareness of the range and operation of counter-narratives to Islamophobia across the EU, and the extent to which these counter-narratives impact and engage with those hostile narratives. The consortium is led by Professor Ian Law and a research team based at the Centre for Ethnicity and Racism Studies, School of Sociology and Social Policy, University of Leeds, UK. The project runs from January 2017 - December 2018.

Research in 2017 was organised around two workstreams. The first workstream described and explained the discursive contents and forms that Islamophobia takes in the eight states considered in the framework of this project. Research in the Portuguese context resulted in the working paper "Dominant Islamophobic Narratives - Portugal", by Marta Araújo. The second workstream examined the operation of identified counter-narratives in a selected range of discursive environments and their impact and influence on public opinion and specific audiences including media and local decision-makers. Research in Portugal resulted in the working paper "Counter-Narratives to Islamophobia in Portugal", by Silvia Maeso.



# » Demonstration Projects and Non-Academic Impact Research

# » EQUI-X – Promoting Innovative-strategies Addressing the Construction of Gender Identities and Engaging Men and Boys in Non-violent Models of Masculinity

Principal Investigator: Tatiana Moura

### Funding: EEAGrant / Portuguese Commission for Gender Equality

EQUI-X is a project funded by EEAGrants, under the Portuguese Commission for Gender Equality, and coordinated by Virgínia Ferreira and Rosa Monteiro, the Local Gender Equality project was implemented between 2015 and 2016. The main goal was to develop methodologies and tools for local governance structures to promote gender equality and the facilitation of reconciliation between spheres of life. Based on a consortium of academic and local governance partner entities, LGE developed the design, experimentation and validation of its products with direct (municipalities) and indirect target audiences (local actors in various domains - such as the economy, culture, sport, urbanism, social action).

The development of tools for the diagnosis, implementation, monitoring and evaluation stages was based on a two-level model of 3 Rs: diagnosis on the Representation of men and women in diverse socioeconomic and political positions, and on the Redistribution of resources between women and men, complemented by the Reflection on the reasons for such realities. This reflection should inspire the desired social change, combating the injustices observed in accessing resources, in recognition and in representation. In keeping with the European Charter, the project took into account the various roles of municipalities as employers, providers of goods and services and regulators of the activities carried out in their territories.

Overall, the team has developed tools for the diagnosis, implementation, monitoring and evaluation of gender equality at the municipal level. At the same time, the project organized training actions targeted at municipal staff members in order to promote the incorporation of the instruments and methods developed.



### >>> ILOCALAPP- Incidentally Learning Other Languages and Cultures through an App

Principal Investigator: Clara Keating

#### Funding: Erasmus + Italian Agency

Framed by increasing international mobility across European universities, ILOCALAPP provides academic and non-academic communities with timely and situated guidance into new cultural and linguistic environments through a mobile application (UniOn!). As app users interact with the new city spaces, they improvise ways of crossing actual institutional, social, historical and cultural obstacles, inhabit those spaces, identify their role in them, and recognize the language resources that carry them through. The challenge consists in negotiating linguistic, historical and cultural identities, as new speakers in emergent contexts.

The geolocalized application UniOn! is inspired by incidental e-learning principles, i.e., neither planned nor intentional, and embeds language and culture in real life situations across four university cities in Finland, Italy, Poland and Portugal. For each spot, UniOn! Coimbra situates the user in the city/ university historical-cultural and social heritage and gives tips for authentic communicative practice in Portuguese. Trajectories for both the city and the language are thus drawn and explored in a unique way by each user in tangential, nonlinear, online and offline ways. With UniOn! users 'do Coimbra' and 'language in Portuguese'; learning emerges as an informal byproduct of other activities configured by broader contextual factors. To make it truly experiential, international students and non-academic communities collaborated throughout the app contents' creation, development and consolidation.

**P**ilocalapp

Centro de Estudos Sociais is home to the Portuguese team, led by Clara Keating, with Olga Solovova (NHUMEP), Anabela Fernandes and Joana Cortez-Smyth (FLUC). Outcomes include an innovative methodological framework, the app and dissemination across the partner's national contexts: media, public/private schools and NGOs. Contents and affordances can be adapted to other audiences, including migrants and refugees.

Building on previous online language/culture learning projects with an established consortium since 2010 (E-Local and E-Local for all), ILOCALAPP is supported by the Erasmus + Italian Agency (2015), coordinated by the University of Bologna (Italy) with partners in Adam Mickiewicz University, Poznań, and in University of Lapland, Rovaniemi.



### » Consolidation of the Rule of Law in African Portuguese Speaking Countries and in Timor-Leste

Principal Investigator: Conceição Gomes

#### Funding: PACED – Camões Institute

The Centre for Social Studies, within the Permanent Observatory for Justice, is organising in each of the Portuguese-speaking African countries (PALOP) and East Timor, meetings of knowledge and experience exchange between institutions whose competencies have impact on preventing and combating corruption, money laundering and organized crime, especially drug trafficking, at the request of Camões, Institute of Portugal. The effectiveness of preventing and combating those crimes greatly depends on the efficient articulation between several institutions of the judicial system (police, public prosecution, courts) and other sectors of the State and the civil society. There are many examples of how the inefficiency of the inter-institutional communication and information circuits, as well as the competencies' overlapping can prejudice both the efficiency of prevention and research and the rights and guarantees of the defendants.

The achievement of these meetings – through the discussion panel methodology that allows an environment conducive to debate, adequately guided by the moderator – aims to promote the cooperation and collaboration reinforcement between those institutions, seeking to increase the quality and effectiveness of the institutional network response in preventing and combating those types of crime. The 12 planned meetings are part of the "Project to Support the Consolidation of the Rule of Law in PALOP and East Timor" (PACED), funded under the regional cooperation program between the European Union and the PALOP and East Timor, co-founded and implemented by Camões, I.P.

In order to enhance the meetings' effectiveness, its organization will try to actively involve the participating institutions in such a way that the issues under debate resemble their expectations as closely as possible, and that the thoughts and strategies for deepening the institutional cooperation result from the participants' own action. It is expected that the meetings will result in recommendations for concrete actions to improve not only inter-institutional cooperation in actions to prevent and combat those types of crime, but also the functional performance of each institution in the development of its own competencies.



### >>> On the Tip of the Tongue: Stories, Memories, and New Narratives on Portuguese Emigration

Principal Investigator: Elsa Lechner

#### **Funding: Calouste Gulbenkian Foundation**

This project is co-financed by the Gulbenkian Foundation program on Portuguese Language and Culture as complementary research for the FCT PROMP.pt research coordinated by Elsa Lechner at CES. The project is based on a partnership with the Portuguese Studies Program at the University of California Berkeley, the Portuguese and Spanish Department at Rutgers-Newark University, the University of Paris-Nanterre Interdisciplinary Research Centre on the Lusophone World (CRILUS), and the Museum of the Person in São Paulo.

Focusing on life narratives produced by Portuguese students in these three countries, (Brazil, France, USA), as well as other Portuguese people living and working abroad, the goal is to deepen the knowledge about Portuguese emigration looking at personal testimonies, family memories, and biographical accounts of participants. Through a digital platform (www.napontadalingua.ces.uc.pt), we are creating an (digital) archive of such stories, experiences and memories, as well as developing interconnectivity among already existing archives, among different Portuguese communities abroad, and those communities and Portugal. Furthermore, the project makes pedagogical use of the oral, written, visual, and performative narratives of participants in their Portuguese language and culture classes, highlighting new self-expressions and creativity.

With the duration of one year (2017/18), the project is actually reaching all interested Portuguese individuals and communities, creating new possibilities for wider networking, connectivity and dialogue with possible further developments. Also, the work with the students who are descendants of emigrants is enabling an interesting and important intergenerational analysis and outcome with relevant consequences for all. Both the young narrators and first-generation listeners/readers/audiences, are getting to know each other in new ways, breaking barriers of age and silence. Portuguese communities in other countries are welcome to participate.





### » RIS3-PE | EU-CELAC Cooperation on Territorial Cohesion for Regional Innovation Systems in the State of Pernambuco (Brazil)

Principal Investigator: Hugo Pinto

### Funding: European Commission – Directorate General for Regional and Urban Policy

RIS3-PE is a project funded by the European Commission DG Regio and coordinated by Hugo Pinto. Influential in the current European regional policy framework and for the ongoing post-2020 reflexion, RIS3 - Smart Specialisation Strategies adopt a systemic perspective of regional innovation, stressing the relevance of selecting a limited number of transformative domains for structural change. The main novelty of RIS3 is the process of entrepreneurial discovery (EDP), the combination of bottom-up approaches and directive government policymaking to identify smart specialisation priorities within the region. In the first steps of RIS3 design it is essential to gather a solid base of evidence on the innovation system dynamics to contribute to the definition of better policies.

The RIS3-PE represents one of the first structured attempts of implementing the RIS3 rationale in innovation policy formulation outside the European context. It intended to contribute to the incorporation of 'smart specialisation' notions in the S&T+I Strategy, which is being developed in the State of Pernambuco (Brazil). Special attention was given to Clothing and Automotive-IT, domains selected as pilot examples, to demonstrate and adapt this approach to the Brazilian context, through the understanding of appropriate forms of multilevel governance and the selection of priority actions.

In 2017 CES coordinated the RIS3-PE in close articulation with SECTI - Pernambuco S&T+I Secretary of State and the National Ministry of Integration. CES developed a series of studies on the Innovation Systemic Failures, Innovation and knowledge needs in Clothing and Automotive-IT, a Vision for the Smart Specialisation Strategy in Pernambuco, a governance model for a future RIS3 in this State, among other deliverables. The project was presented both in Recife and Brasilia and two EDP workshops were organized, one for each sector. It is anticipated that RIS3 rationale will, in the near future, be further developed and adapted to Latin America and specifically to Brazil.

### >>> ENED – National Development Education Strategy



#### Funding: Camões Institute

This project's main objective was to support the elaboration process of the second Portuguese National Development Education Strategy (ENED). The elaboration process was based on an intensive interaction among three groups:

- the CES team Paula Duarte Lopes, Sílvia Roque, Daniela Nascimento and Rita Santos;
- the ENED 2010-2016 Monitoring Commission with representatives from Camões, I.P. (the Portuguese Development Aid Institute), the Education Directorate-General, the Portuguese Platform of Non-Governmental Organizations Development (ONGD), and CIDAC (a ONGD representing GENE Global Education Network Europe);
- 3. the ENED 2010-2016 Subscribing Entities – including governmental and non-governmental entities from various sectors, such as development, environment, education, intercultural, women's rights, sports and youth, local development, migration, development cooperation, higher education schools.

The final document (currently awaiting ministerial approval) was a result of an intensive collective reflection and discussion on conceptual, strategic and governing aspects of the ENED. The process included four workshops with the Subscribing Entities, based on group work characterized by a participatory approach and mediated by the CES team. The project's specific objectives included 1) framing the new version of the Portuguese ENED, based on both national and international trends and dynamics; 2) identifying conceptual, strategic and governing points of consensus/divergence, and proposing associated possibilities for compromise; and 3) writing in a participative manner the ENED 2017-2022. This project was in and of itself a development education process, due to the way in which it was developed, where participants were active leading figures in the overall learning process and where coherence, solidarity, co-responsibility, participation, cooperation, non-discrimination, among other principles, characterized the work jointly developed.





During 2017, CES was mentioned in the news 327 times, with particular emphasis on national media outlets (260), including the printed and online press, radio and television channels (led by Público, Diário de Notícias, LUSA, Expresso, RTP/RDP and Jornal de Notícias, in this order). Regionally, 89 articles with references to CES were published (mostly Diário de Coimbra and As Beiras). The international media mentioned CES 29 times, in Spain (11), Italy (8), Brazil (5), France (1), Venezuela (1), Colombia (1), Mexico (1) and United Kingdom (1).





In 2017, interaction with the general public was expanded through Twitter (1,799 followers) and Facebook (16,827 friends).




#### > Websites page views

**CES Websites Hits** 


As for the CES website, according to Google Analytics, there were 1,011,866 direct hits during 2017, not including hits on research projects/ publication websites outside the CES server. Several other hits, regarding specific ERC research projects, should be added to return 1,059,830 as the real number – Intimate (10,627), Memoirs (9,749), Exchange (5,946) and Alice (21,642).


The 2017 budget increased more than 100,000 euros when compared to 2016, mainly due to funding from the Portuguese Foundation for Science and Technology (FCT). CES has steadily registered an improvement in funding amounts per project during the last years. Larger projects, with larger budgets, have impacted positively on the centre's overall budget. Nevertheless, in 2017 CES registered a transition year, due to the end of some international funded projects and the increase of the Associate Laboratory/FCT funding scheme. In 2018, with the beginning of new international funded research projects, a return to the trend observed in the last 10 years is estimated.



The global budget for 2017 amounted to over 4,6 million euros, of which 31% (27% in 2016) stemmed from FCT contractual funding for research institutions. This increase in percentage (around 4%) is a reflection of a slightly reduction of amounts of competitive funding secured at both the national and international levels (especially the delay of the results of the FCT competitive funding scheme for research projects). Nevertheless, it is remarkable that 69% of the global annual CES funding is obtained through competitive funding and other funding schemes, a reality that has no parallel in any other Portuguese social science or humanity research institution.

Analysis of the funding obtained in competitive settings reflects the continuity of CES internationalisation process, with good results in the funding obtained in international calls and tenders (amounting to 1,5 million euros in 2017, more than one third - 33,5% - of the CES annual budget). Although national funding for research, particularly from the FCT, was planned to increase in 2017, that did not happen, negatively influencing the expected global results. CES shall continue to strategically target international calls, following successful applications to, among others, Research and Innovation Actions, ERC grants and Marie Sklodowska-Curie Actions, under Horizon 2020, or DG Justice, DG Regio, among many others. This internationalization of research and funding has proved highly advantageous from both the financial and the scientific research perspectives.

The overall number of research projects funded slightly increased, with a tendency to stabilize, simultaneously with an increase in the size of each project. This factor is of great importance to securing and ensuring the necessary training of a new generation of researchers hired after increasingly competitive recruitment calls.
